The Social Security (Incapacity) (Miscellaneous Amendments) Regulations 2003

Made	2nd September 2003
Laid before Parliament	10th September 2003
Coming into force	1st October 2003

The Secretary of State for Work and Pensions, in exercise of powers conferred by sections 30E, 122(1), 171D, 171G(2), 175(1) to (4) of, and paragraph 2(3) of Schedule 7 to, the Social Security Contributions and Benefits Act 1992(1) and of all other powers enabling him in that behalf, after agreement by the Social Security Advisory Committee and the Industrial Injuries Advisory Council that proposals to make these Regulations should not be referred to it(2), hereby makes the following Regulations:

Citation and commencement

1. These Regulations may be cited as the Social Security (Incapacity) (Miscellaneous Amendments) Regulations 2003 and shall come into force on 1st October 2003.

Amendment of regulation 16 of the Social Security (General Benefit) Regulations 1982

2. In regulation 16 of the Social Security (General Benefit) Regulations 1982(**3**) (earnings level that does not disqualify for unemployability supplement) for the sum "£3,510" there shall be substituted the sum "£3,744".

Amendment of regulation 8 of the Social Security (Incapacity Benefit) Regulations 1994

3. In regulation 8 of the Social Security (Incapacity Benefit) Regulations 1994(**4**) (limit of earnings from councillor's allowance) for the sum "£67.50" there shall be substituted the sum "£72.00".

Amendment of regulation 17 of the Social Security (Incapacity for Work) (General) Regulations 1995

4. In regulation 17(2)(a) of the Social Security (Incapacity for Work) (General) Regulations 1995 (exempt work) for the sum(**5**) "£67.50" there shall be substituted the sum "£72.00".

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations amend the Social Security (General Benefit) Regulations 1982, the Social Security (Incapacity Benefit) Regulations 1994 and the Social Security (Incapacity for Work) (General) Regulations 1995.

Regulation 2 amends regulation 16 of the Social Security (General Benefit) Regulations 1982 by increasing from $\pounds 3,510$ to $\pounds 3,744$ the amount which can be earned before disqualification for unemployability supplement.

Regulation 3 amends regulation 8 of the Social Security (Incapacity Benefit) Regulations 1994 by increasing the earnings limit for councillor's allowance from £67.50 to £72.00.

Regulation 4 amends regulation 17 of the Social Security (Incapacity for Work) (General) Regulations 1995 by increasing from $\pounds 67.50$ to $\pounds 72.00$ the weekly limit for earnings from work which may be undertaken by a person without his being treated as being capable of work.

These Regulations do not impose any costs on business.
