The Local Authorities (Conduct of Referendums) (England) (Amendment) Regulations 2004

Amendment of conduct of referendums regulations

- **2.**—(1) The Local Authorities (Conduct of Referendums) (England) Regulations 2001(1) shall be amended as follows.
 - (2) In regulation 2(1), insert in the appropriate place in alphabetical order—
 - "the Combination of Polls Regulations" means the Representation of the People (Combination of Polls) (England and Wales) Regulations 2004(2);
 - "European Parliamentary election" shall have the same meaning as in section 27(1) of the 1985 Act;
 - "local government election" shall have the same meaning as in section 203(1) of the 1983 Act(3);
 - "mayoral election" shall have the same meaning as in the Local Authorities (Mayoral Elections) (England and Wales) Regulations 2002(4);
 - "relevant election or referendum" means one or more of the following—
 - (i) another referendum, (including a further referendum);
 - (ii) a Parliamentary election(5);
 - (iii) a European Parliamentary election;
 - (iv) a local government election;
 - (v) a mayoral election;
 - the poll at which is taken together with the poll at the referendum(6).".
 - (3) For regulation 15(4), substitute—
 - "(4) The 1985 Act and the Elections Regulations shall have effect subject to the further modifications provided for in Part I of Schedule 5.
 - (4A) The Principal Areas Rules shall have effect subject to the modifications set out in Part II of Schedule 5."
 - (4) In regulation 16—
 - (a) in paragraph (6), omit the words "the 1986 Regulations"; and
 - (b) omit paragraph (8).
 - (5) For regulation 17(4), substitute—

- "(4) Where the poll at a referendum is combined with the poll at another referendum, the Principal Areas Rules, modified as set out in Schedule 3 to those Rules shall have effect in relation to the referendum, subject to the modifications set out in Part II of Schedule 5; and a provision set out in column 1 of that Part and expressed to apply only in the circumstances there mentioned, and any modification shown in column 2 as applicable to any such provision, shall have effect only in those circumstances."
- (6) Regulations 15(5), (7) and (9), and 16(4), (5) and (7) are revoked.
- (7) For Schedule 5, substitute Schedule 5 as set out in the Schedule to these Regulations.
