## The Crime (International Co-operation) Act 2003 (Commencement No. 1) Order 2004

Made - - - - 16th March 2004

Whereas the day appointed for the coming into force of the provisions of Part 1 of the Crime (International Co-operation) Act 2003(a) which are listed in articles 2 and 3 of this Order is one decided on by the Secretary of State and the Scottish Ministers;

Now, therefore, in exercise of the powers conferred on him by section 94 of that Act, the Secretary of State hereby makes the following Order:

- **1.**—(1) The Order may be cited as the Crime (International Co-operation) Act 2003 (Commencement No. 1) Order 2004.
  - (2) In this Order "the Act" means the Crime (International Co-operation) Act 2003.
  - 2. Sections 49 to 51 of the Act shall come into force on 26th March 2004.
  - 3.—(1) The following provisions of the Act shall come into force on 26th April 2004.
  - sections 1 to 9;
    sections 13 to 19, together with Schedule 1;
    sections 26 to 31, together with Schedule 2;
    sections 47 and 48;
    sections 52 and 53;
    sections 80 to 85;
    section 88;
    section 91;
    paragraphs 1 to 4, 7 to 16, 38 to 44, 61 to 71, 75 to 83 of Schedule 5; and
  - (3) The entries in Schedule 6 (repeals) are those relating to—the Criminal Justice Act 1987(**b**); the Criminal Justice (International Co-operation) Act 1990(**c**); the Criminal Justice and Public Order Act 1994(**d**);

the entries in Schedule 6 which are listed in paragraph (3).
