Dietr., *Pinus* L., *Platanus* L., *Populus* L., *Prunus laurocerasus* L., *Prunus lusitanica* L., *Pseudotsuga* Carr., *Quercus* L., *Rubus* L., *Spinacia* L., *Tanacetum* L., *Tsuga* Carr., *Verbena* L. or other plants of herbaceous species other than plants of the family *Gramineae* and other than bulbs, corms, rhizomes or tubers;

"Golden Yellow", *Galanthus* L., *Galtonia candicans* (Baker) Decne, miniature cultivars of the genus *Gladiolus* Tourn.
