The Secretary of State, in exercise of the powers conferred upon him by section 80 of the Criminal Justice and Court Services Act 2000(a) hereby makes the following Order:

- **1.** This Order may be cited as the Criminal Justice and Court Services Act 2000 (Commencement No. 14) Order 2005.
- **2.** Section 57 of the Criminal Justice and Court Services Act 2000(**b**) (testing persons in police detention) shall come into force on 1st April 2005 within the following police areas(**c**)—
 - (a) Gwent;
 - (b) Northamptonshire; and
 - (c) South Wales.
