The Secretary of State makes the following Order in exercise of the powers conferred by section 107 of the Natural Environment and Rural Communities Act 2006<sup>(a)</sup>:

**Citation and extent**

1. This Order may be cited as the Natural Environment and Rural Communities Act 2006 (Commencement No. 2) Order 2006 and extends to England and Wales.

**Provisions coming into force on 31st May 2006**

2. The following provisions of the Natural Environment and Rural Communities Act 2006 come into force on 31st May 2006—

- section 47;
- section 52 and Schedule 5;
- section 53 and Schedule 6;
- sections 56 and 57;
- sections 78 and 79;
- section 80 and Schedule 7;
- sections 81 to 86.
