The Serious Organised Crime and Police Act 2005 (Commencement) (No. 7) Order 2006

The Secretary of State, in exercise of the powers conferred by section 178(8) and (9) of the Serious Organised Crime and Police Act 2005(a), makes the following Order:—

- **1.** This Order may be cited as the Serious Organised Crime and Police Act 2005 (Commencement) (No. 7) Order 2006.
- **2.** Section 144 of and Schedule 10 to the Serious Organised Crime and Police Act 2005 (parental compensation orders)(b) shall come into force on 20th July 2006 in the areas specified in the Schedule to this Order.
