#### Citation

**1.** This Order may be cited as the Domestic Violence, Crime and Victims Act 2004 (Commencement No. 6) Order 2006.

#### Commencement

**2.** Section 55 of the Domestic Violence, Crime and Victims Act 2004 (victims' advisory panel) shall come into force on 4th October 2006.
