The Treasury, in exercise of the powers conferred by section 417(1)(a) and 426(1) of the Financial Services and Markets Act 2000 (b), make the following Order:

**Citation, commencement and effect**

1. This Order may be cited as the Lloyd's Sourcebook (Finance Act 1993 and Finance Act 1994) (Amendment) Order 2006 and comes into force on 31st December 2006.

**Amendment of the Finance Act 1993**

2. In section 184(1) of the Finance Act 1993(c) for "section 17.7 of the Lloyd's Sourcebook" substitute "Rule 8.2.19 of the Insurance Prudential Sourcebook".

**Amendment of the Finance Act 1994**

3. In section 230 of the Finance Act 1994(d) for "section 17.7 of the Lloyd's Sourcebook" substitute "Rule 8.2.19 of the Insurance Prudential Sourcebook".

**Revocation of the Lloyd's Sourcebook (Amendment of the Finance Act 1993 and the Finance Act 1994) Order 2005**

4. The Lloyd's Sourcebook (Amendment of the Finance Act 1993 and the Finance Act 1994) Order 2005(e) is revoked.
