## PART 1

### AMENDMENTS ABOUT ELIGIBILITY FOR APPOINTMENT AS AUDITOR AND RELATED MATTERS

2. In the following provisions <sup>M1</sup>, for “company auditor under Article 28 of the Companies (Northern Ireland) Order 1990” substitute “statutory auditor under Part 42 of the Companies Act 2006”

- (a) section 10(1) of the Pig Production Development Act (Northern Ireland) 1964 <sup>M2</sup> (accounts of Pig Production Development Fund);
- (b) section 41(1) of the Industrial and Provident Societies Act (Northern Ireland) 1969 <sup>M3</sup> (accounts of industrial and provident societies);
- (c) Article 20(3) of the Legal Aid, Advice and Assistance (Northern Ireland) Order 1981 <sup>M4</sup> (accounts of legal aid fund);
- (d) Article 46(1) of the Credit Unions (Northern Ireland) Order 1985 <sup>M5</sup> (accounts of credit unions);
- (e) the definition of “qualified accountant” in Article 2(2) of the Betting, Gaming, Lotteries and Amusements (Northern Ireland) Order 1985 <sup>M6</sup>;
- (f) Article 10(2) of the Horse Racing (Northern Ireland) Order 1990 <sup>M7</sup> (accounts of Governor and Freemen of the Corporation of Horse Breeders, in the County of Down and of the Downpatrick Race Club);
- (g) paragraph 6 of Schedule 1 to the Industrial Relations (Northern Ireland) Order 1992 <sup>M8</sup> (accounts of trade unions and employers' associations).
