The Secretary of State, in exercise of the powers conferred by sections 48(6) and 53(4) of the Justice and Security (Northern Ireland) Act 2007(a), makes the following Order:

Citation

1. This Order may be cited as the Justice and Security (Northern Ireland) Act 2007 (Commencement No.3) Order 2009.

Commencement of provisions

- **2.**—(1) The provisions of the Justice and Security (Northern Ireland) Act 2007 specified in paragraph (2) shall come into force on 8 March 2009.
 - (2) The provisions referred to in paragraph (1) are—
 - (a) section 48(3) to (5) (Private Security Industry); and
 - (b) section 49 (Amendments of the Private Security Industry Act 2001(b)).
- **3.**—(1) The provisions of the Justice and Security (Northern Ireland) Act 2007 specified in paragraph (2) shall come into force on 11 March 2009.
 - (2) The provisions referred to in paragraph (1) are
 - (a) section 44 (Northern Ireland department with policing and justice functions); and
 - (b) Schedule 5 (Northern Ireland department with policing and justice functions).
