# The Northern Ireland (Miscellaneous Provisions) Act 2006 (Commencement No.5) Order 2009

*Made - - - - 2nd March 2009* 

The Secretary of State, in exercise of the powers conferred by section 31(3) of the Northern Ireland (Miscellaneous Provisions) Act 2006(a), makes the following Order:

#### Citation

**1.** This Order may be cited as the Northern Ireland (Miscellaneous Provisions) Act 2006 (Commencement No. 5) Order 2009.

#### **Commencement of provisions**

- **2.**—(1) The provisions of the Northern Ireland (Miscellaneous Provisions) Act 2006 specified in paragraph (2) shall come into force on 11 March 2009.
  - (2) The provisions referred to in paragraph (1) are—
    - (a) section 16 (conditions for devolving policing and justice matters);
    - (b) section 17 together with Schedule 2 (department with policing and justice functions);
    - (c) section 18 (power of Assembly to call for witnesses and documents);
    - (d) section 19 (provision for transfer of functions relating to extradition etc.);
    - (e) section 20 (provision for entrenching enactments);
    - (f) section 30(1) (minor and consequential amendments etc.) in so far as it relates to the provision referred to in sub-paragraph (g); and
    - (g) Part 3 of Schedule 4 (devolution of policing and justice functions etc.).
