### Citation, commencement and interpretation

- 1.—(1) This Order may be cited as the Pharmacy Order 2010 (Commencement No. 2) Order of Council 2010 and comes into force on 27th September 2010.
  - (2) In this Order, "the Order" means the Pharmacy Order 2010.

### Appointed day

- **2.**—(1) Subject to paragraph (2), the day appointed for the coming into force of the provisions of the Order which are specified in the Schedule is 27th September 2010.
  - (2) The day appointed for the coming into force of
    - (a) paragraphs (6) to (10) of article 24 of the Order; and
    - (b) paragraph (2) of article 40 of the Order, in so far as it relates to paragraphs (6) to (10) of article 24 of the Order,

is 4th January 2011.

Sub-paragraph (1) of article 2 appoints 27th September 2010 as the day for the coming into force of the provisions of the Order which are specified in the Schedule. Sub-paragraph (2) of article 2 appoints 4th January 2011 as day for the coming into force of certain other provisions of the Order.
