**The Borders, Citizenship and Immigration  
Act 2009 (Commencement No.2) Order 2011**

*Made - - - - 14th July 2011*

The Lord Chancellor makes the following Order in exercise of the powers conferred by section 58(4)(a) of the Borders, Citizenship and Immigration Act 2009<sup>(1)</sup>.

The Lord Chancellor has satisfied the requirements of section 58(16) of that Act by transferring the functions of the Asylum and Immigration Tribunal under section 30(1) of the Tribunals, Courts and Enforcement Act 2007<sup>(2)</sup>.

**Citation**

1. This Order may be cited as the Borders, Citizenship and Immigration Act 2009 (Commencement No.2) Order 2011.

**Appointed date**

2. The date appointed for the coming into force of section 53 (transfer of certain immigration judicial review applications) of the Borders, Citizenship and Immigration Act 2009 is 8th August 2011.
