The Driving Theory Test Fees (Various Amendments) Regulations 2014

The Secretary of State for Transport, in exercise of the powers conferred by sections 89(3), (4), (5) and (5ZA), 105(1), (3) and (4), 132 and 141 of the Road Traffic Act 1988⁽¹⁾, section 2(2) of the European Communities Act 1972⁽²⁾ and section 56(1) and (2) of the Finance Act 1973⁽³⁾, by virtue of the Department of Transport (Fees) Order 1988⁽⁴⁾ and, in the case of section 89 of the 1988 Act and section 56 of the 1973 Act, with the approval of the Treasury, makes the following Regulations.

The Secretary of State for Transport is a Minister designated for the purposes of section 2(2) of the European Communities Act 1972⁽⁵⁾ in relation to the regulation and supervision of the qualifications and working conditions of persons engaged in road transport.

The Secretary of State for Transport has consulted with representative organisations in accordance with section 195(2) of the Road Traffic Act 1988.
