**The Merchant Shipping (Miscellaneous Provisions)
(Amendments etc.) (EU Exit) Regulations 2018**

PART 1

Amendment of secondary legislation

Amendments which take effect before exit day

3.—(1) In each of the regulations specified in paragraph (2), omit the definition of “EEA Agreement” and for the definition of “EEA State” substitute—

““EEA State” has the meaning given by Schedule 1 to the Interpretation Act 1978^{M1}.”.

(2) The regulations specified for the purpose of paragraph (1) are—

- (a) regulation 2(1) of the Merchant Shipping (Cargo Ship Construction) Regulations 1997^{M2},
- (b) regulation 1(2) of the Merchant Shipping (Fire Protection: Small Ships) Regulations 1998^{M3},

- (i) regulation 2(2) of the Merchant Shipping (Life-Saving Appliances For Passenger Ships of Classes III To VI(A)) Regulations 1999^{M8}, and
- (j) regulation 2(1) of the Merchant Shipping (Ro-Ro Passenger Ships) (Stability) Regulations 2004^{M9}.

(3) In each of the regulations specified in paragraph (4) for the definition of “EEA State” substitute—

““EEA State” has the meaning given by Schedule 1 to the Interpretation Act 1978.”.

(4) The regulations specified for the purpose of paragraph (3) are—

- (a) regulation 1(2) of the Merchant Shipping (Registration of Ships) Regulations 1993^{M10}, and
- (b) regulation 2(1) of the Merchant Shipping (Mandatory Surveys for Ro-Ro Ferry and High Speed Passenger Craft) Regulations 2001^{M11}.
