**The European Union (Withdrawal) Act 2018 (Commencement  
No. 4) Regulations 2019**

The Secretary of State, in exercise of the powers conferred by section 25(4) of the European Union (Withdrawal) Act 2018(a), makes the following Regulations:

**Citation**

1. These Regulations may be cited as the European Union (Withdrawal) Act 2018 (Commencement No. 4) Regulations 2019.

**Appointed day**

2. The day appointed for the coming into force of section 1 (repeal of the European Communities Act 1972(b)) of the European Union (Withdrawal) Act 2018 is the day after the day on which these Regulations are made.

**EXPLANATORY NOTE**

*(This note is not part of the Regulations)*

These Regulations are the fourth set of commencement regulations made under the European Union (Withdrawal) Act 2018 (c. 16). Regulation 2 brings section 1 of that Act into force on the day after the day on which these Regulations are made. Section 1 provides that the European Communities Act 1972 (c. 68) is repealed on exit day.

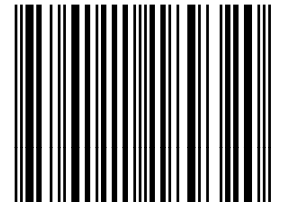
