The Immingham Open Cycle Gas Turbine Order 2020 ("the Order")(1), which granted development consent within the meaning of the Planning Act 2008 ("the Act")(2), contains correctable errors within the meaning of paragraph 1 of Schedule 4 to the Act.

EXPLANATORY NOTE

This Order corrects errors and omissions in the Immingham Open Cycle Gas Turbine Order 2020, a development consent order under the Planning Act 2008, following a written request under paragraph 1(5)(a) of Schedule 4 to that Act.
