Mae'r Gorchymyn hwn yn dod â darpariaethau penodol o Ddeddf Dysgu a Medrau 2000 i rym ar 1 Ionawr 2001. Rhestrir y darpariaethau hynny, ac esbonnir eu heffeithiau, isod.

Mae adrannau 42, 43 a 44 yn gosod dyletswyddau ar Gyngor Cenedlaethol Cymru dros Addysg a Hyfforddiant. Mae adran 42 yn ei gwneud yn ofynnol i'r Cyngor roi sylw priodol i hyrwyddo cyfleoedd cyfartal wrth arfer ei swyddogaethau. Mae adrannau 43 a 44 yn ei gwneud yn ofynnol i'r Cyngor wneud cynllun ar gyfer pob un o'i flynyddoedd ariannol a llunio strategaeth mewn perthynas â'i swyddogaethau.

Mae adrannau 46 a 48 yn rhoi pwerau atodol i'r Cyngor sy'n angenrheidiol i ganiatáu iddo gyflawni ei swyddogaethau a sefydlu pwyllgorau.

Mae adran 73 yn ailenwi Prif Arolygydd Ysgolion Ei Mawrhydi yng Nghymru ac Arolygwyr Ysgolion Ei Mawrhydi yng Nghymru. Mae adran 87 yn ei gwneud yn ofynnol i'r Prif Arolygydd baratoi cynllun blynyddol a'i gyflwyno i'r Cynulliad Cenedlaethol ar gyfer ei gymeradwyo.

Mae adrannau 93 a 95 yn rhoi pŵer i'r Cynulliad Cenedlaethol wneud cynlluniau ar gyfer trosglwyddo i'r Cyngor eiddo, hawliau a rhwymedigaethau (gan gynnwys hawliau cyflogaeth) sy'n gysylltiedig â'r ffaith bod y Cyngor yn ymgymryd â'i swyddogaethau.

This Order brings into force on 1st January 2001 certain provisions of the Learning and Skills Act 2000. Those provisions are listed, and their effect explained, below.

Sections 42, 43 and 44 impose duties on the National Council for Education and Training for Wales. Section 42 requires the Council to have due regard to the promotion of equality of opportunity in the exercise of its functions. Sections 43 and 44 require the Council to make a plan for each of its financial years and to formulate a strategy in relation to its functions.

Sections 46 and 48 give the Council supplementary powers necessary to enable it to carry out its functions and to establish committees.

Section 73 renames Her Majesty's Chief Inspector of Schools in Wales and Her Majesty's Inspectors of Schools in Wales. Section 87 requires the Chief Inspector to prepare an annual plan and submit it to the National Assembly for approval.

Sections 93 and 95 empower the National Assembly to make schemes for the transfer to the Council of property, rights and liabilities (including employment rights) associated with the acquisition by the Council of its functions.

Mae adran 141 yn rhoi pŵer i'r Cynulliad Cenedlaethol, o dan amgylchiadau penodol, gyfarwyddo cwmnïau y mae wedi contractio gyda hwy mewn perthynas â darparu hyfforddiant i beidio â chymryd camau penodol. Mae'n rhoi pŵer hefyd i'r Cynulliad Cenedlaethol wneud rheoliadau sy'n rhagnodi'r mathau o gamau y gellir eu cynnwys mewn cyfarwyddiadau o'r fath.

Mae adran 145 yn ymdrin â rhwymedigaeth sifil llywodraethwyr sefydliadau addysg bellach penodol.

Mae Atodlenni 9 ac 11 yn eu tro yn cynnwys diwygiadau a diddymiadau canlyniadol.

Nodyn ynghylch Gorchmynion Cychwyn cynharach

Daethpwyd neu deuir â darpariaethau canlynol Deddf Dysgu a Medrau 2000 i rym mewn perthynas â Chymru drwy orchmynion cychwyn a wnaed cyn dyddiad y Gorchmyn hwn.

Section 139 allows induction periods for teachers to be served in further education institutions in some circumstances.

Section 141 empowers the National Assembly, in certain circumstances, to direct companies with whom it has contracted in respect of the provision of training not to take certain actions. It also empowers the National Assembly to make regulations prescribing the types of actions which may be included in such directions.

Section 145 deals with the civil liability of governors of certain further education institutions.

Schedules 9 and 11 respectively contain consequential amendments and repeals.

1.-(1) This Order may be cited as the Learning and Skills Act 2000 (Commencement No. 2) (Wales) Order 2000.
