# **EDUCATION, WALES**

The Education (School Information) (Wales) (Amendment) Regulations 2001

### **EXPLANATORY NOTE**

(This note does not form part of the Regulations)

These Regulations amend the Education (School Information) (Wales) Regulations 1999 which provide for (amongst other things) the information which must be included in the school prospectus. Four additional items relating to arrangements for disabled pupils, equal opportunities' policies, school security and the home-school agreement adopted by the school are now to be included in the school prospectus - see Regulation 2.

Drwy arfer y pwerau a roddwyd i'r Ysgrifennydd Gwladol gan adrannau 537(1) a (4) a 569(4) a (5) o Ddeddf Addysg 1996(**a**) ac a freiniwyd bellach yng Nghynulliad Cenedlaethol Cymru(**b**), mae Cynulliad Cenedlaethol Cymru, ar ôl ymgynghori â'r personau hynny yr oedd yn ymddangos iddo fod ymgynghori â hwy yn ddymunol, drwy hyn yn gwneud y Rheoliadau canlynol:

#### Enwi, cychwyn a chymhwyso

**1.-**(1) Enw'r Rheoliadau hyn yw Rheoliadau Addysg (Gwybodaeth Ysgolion) (Cymru) (Diwygio) 2001 a deaunt i rym ar 1 Medi 2001.

(2) Mae'r Rheoliadau hyn yn gymwys i Gymru yn unig.

#### Diwygio Rheoliadau

**2.-**(1) Diwygir Rheoliadau Addysg (Gwybodaeth Ysgolion) (Cymru) 1999(c) fel a ganlyn.

(2) Ar ôl paragraff 14 o Atodlen 3 i'r Rheoliadau hynny mewnosodwch -

"14A. Particulars of any special arrangements for the admission of disabled pupils to the school and for enabling such pupils to have access to any part of the school premises, together with particulars of any steps which have been taken to prevent disabled pupils from being treated less favourably than pupils who are not disabled.

## **EDUCATION, WALES**

The Education (School Information) (Wales) (Amendment) Regulations 2001

Made	15th March 2001
Coming into force	1st September 2001

In exercise of the powers conferred on the Secretary of State by sections 537(1) and (4) and 569(4) and (5)of the Education Act  $1996(\mathbf{a})$  and now vested in the National Assembly for Wales(**b**), the National Assembly for Wales, after consulting those persons with whom consultation appeared to it to be desirable, hereby makes the following Regulations:

#### Citation, commencement and application

**1.-**(1) These Regulations may be cited as the Education (School Information) (Wales) (Amendment) Regulations 2001 and shall come into force on 1st September 2001.

(2) These Regulations apply only in Wales.

#### **Amendment of Regulations**

**2.-**(1) The Education (School Information) (Wales) Regulations 1999(c) are amended as follows.

(2) After paragraph 14 of Schedule 3 to those Regulations insert -

"14A. Particulars of any special arrangements for the admission of disabled pupils to the school and for enabling such pupils to have access to any part of the school premises, together with particulars of any steps which have been taken to prevent disabled pupils from being treated less favourably than pupils who are not disabled.

14D. A summary of the provisions contained in the home-school agreement adopted by the governing body of the school under section 110(1) of the 1998 Act.".
