### **EDUCATION, WALES**

The General Teaching Council for Wales (Functions) (Amendment) Regulations 2001

### **EXPLANATORY NOTE**

*(This note does not form part of the Regulations.)*

These Regulations amend the General Teaching Council for Wales (Functions) Regulations 2000.

They make provisions for the Register of teachers maintained by the General Teaching Council for Wales to record the terms of disciplinary orders made by the General Teaching Council for Wales or the General Teaching Council for England. Reprimands issued by either of these Councils are to remain on the Register for a period of two years from the date the reprimand is issued.

The Regulations also make provision for this information to be passed to employers upon request.

Drwy arfer y pwerau a roddwyd i'r Ysgrifennydd Gwladol gan adrannau 4(1), 4(2)(d), 4(3), 14(3) a 42(6) a (7) o Ddeddf Addysgu ac Addysg Uwch 1998(a) ac sydd wedi'u breiniio bellach yng Nghynulliad Cenedlaethol Cymru(b), ac ar ôl ymgynghori â Chyngor Addysgu Cyffredinol Cymru yn unol ag adran 42(9) o'r Ddeddf honno, mae Cynulliad Cenedlaethol Cymru yn gwneud y Rheoliadau canlynol:

**Enwi a chychwyn**

1. Enw'r Rheoliadau hyn yw Rheoliadau Cyngor Addysgu Cyffredinol Cymru (Swyddogaethau) 2001 a deuant i rym ar 1 Awst 2001.

**Diwygio Rheoliadau Cyngor Addysgu Cyffredinol Cymru (Swyddogaethau) 2000**

2. Mae Rheoliadau Cyngor Addysgu Cyffredinol Cymru (Swyddogaethau) 2000(c) yn cael eu diwygio -

(a) drwy fewnosod y canlynol ar ôl "Atodlen 1" ar ddiwedd rheoliad 6(1):

"am unrhyw gyfnod (os o gwbl) a bennir yn yr Atodlen honno";

(b) drwy fewnosod y paragraffau canlynol ar ôl paragraff 22 o Atodlen 1 :

**"22A.** Telerau unrhyw orchymyn disgynnu, heblaw cerydd, sydd mewn grym am y tro, a wnaed gan y Cyngor neu gan Gyngor Addysgu Cyffredinol Lloegr.

(a) 1998 p.30. Mae'r darpariaethau perthnasol yn gymwys i Gyngor Addysgu Cyffredinol Cymru yn rhinwedd adrannau 8 a 9 o'r Ddeddf a Gorchymyn Cyngor Addysgu Cyffredinol Cymru 1998 (O.S. 1998/2911). I gael ystyr "prescribed" a "regulations" gweler adran 43(1).

(b) Gweler Gorchymyn Cynulliad Cenedlaethol Cymru (Trosglwyddo Swyddogaethau) 1999 (O.S. 1999/672).

**2001 No. 2496 (W. 200 )****EDUCATION, WALES****The General Teaching Council for Wales (Functions) (Amendment) Regulations 2001***Made**5th July 2001**Coming into force**1st August 2001*

In exercise of the powers conferred on the Secretary of State by sections 4(1), 4 (2)(d), 4(3), 14(3) and 42(6) and (7) of the Teaching and Higher Education Act 1998(a) and now vested in the National Assembly for Wales(b), and having consulted the General Teaching Council for Wales in accordance with section 42(9) of that Act, the National Assembly for Wales makes the following Regulations:

**Citation and commencement**

1. These Regulations are called the General Teaching Council for Wales (Functions)(Amendment) Regulations 2001 and shall come into force on 1st August 2001.

**Amendment of the General Teaching Council for Wales (Functions) Regulations 2000**

2. The General Teaching Council for Wales (Functions) Regulations 2000(c) are amended by -

(a) the insertion after "Schedule 1" at the end of regulation 6(1) of the following:

"for such period (if any) as is specified in that Schedule";

(b) the insertion after paragraph 22 of Schedule 1 of the following paragraphs:

**"22A.** The terms of any disciplinary order, other than a reprimand, for the time being in force, made by the Council or the General Teaching Council for England.

- 22B.** Telerau unrhyw gerydd a roddwyd gan y Cyngor neu gan Gyngor Addysgu Cyffredinol Lloegr, am gyfnod o ddwy flynedd o'r dyddiad y rhoddwyd y cerydd."; a
- (c) drwy fewnosod y paragraffau canlynol ar ôl paragraff 13 o Atodlen 2:

"**13A.** Telerau unrhyw orchymyn disgynblu, heblaw cerydd, sydd am y tro mewn grym, a wnaed gan y Cyngor neu gan Gyngor Addysgu Cyffredinol Lloegr.

**13B.** Telerau unrhyw gerydd a roddwyd gan y Cyngor neu gan Gyngor Addysgu Cyffredinol Lloegr ac a gofndowyd ar y gofrestr."

**22B.** The terms of any reprimand issued by the Council or the General Teaching Council for England, for a period of two years from the date the reprimand was issued."; and

- (c) the insertion after paragraph 13 of Schedule 2 of the following paragraphs:

"**13A.** The terms of any disciplinary order, other than a reprimand, for the time being in force, made by the Council or the General Teaching Council for England.

**13B.** The terms of any reprimand issued by the Council or the General Teaching Council for England and recorded on the register."
