Mae'r Gorchymyn hwn yn diwygio Gorchymyn Cyngor Addysgu Cyffredinol Cymru (Swyddogaethau Ychwanegol) 2000. Mae'n darparu ar gyfer cofnodi unrhyw orchmynion disgyblu sy'n cael eu gwneud yn erbyn athro neu athrawes gan Gyngor Addysgu Cyffredinol Cymru neu gan Gyngor Addysgu Cyffredinol Lloegr. Mae ceryddon sy'n cael eu rhoi gan y naill neu'r llall o'r Cyngorau i'w cofnodi yn erbyn enw'r athro neu'r athrawes am gyfnod o ddwy flynedd o'r dyddiad pan fydd y cerydd yn cael ei roi.

This Order amends The General Teaching Council for Wales (Additional Functions) Order 2000. It provides for the recording of any disciplinary orders made against a teacher by the General Teaching Council for Wales or the General Teaching Council for England. Reprimands issued by either of the Councils are to be recorded against the name of the teacher for a period of 2 years from the date the reprimand is issued.

Drwy arfer y pwerau a roddwyd i'r Ysgrifennydd Gwladol gan adrannau 7(1) a (4) a 42(6) a (7) o Ddeddf Addysgu ac Addysg Uwch 1998(a) ac sydd wedi'u breinio bellach yng Nghynulliad Cenedlaethol Cymru(b), mae Cynulliad Cenedlaethol Cymru, gan ei fod o'r farn y gall Cyngor Addysgu Cyffredinol Cymru, o ystyried eu hamcanion cyffredinol, gyflawni'n briodol y swyddogaethau ychwanegol a roddir drwy hyn ac ar ôl cyflawni unrhyw ymgynghori y mae'n ymddangos iddo ei fod yn briodol, yn gwneud y Gorchymyn canlynol:

In exercise of the powers conferred on the Secretary of State by sections 7(1) and (4) and 42(6) and (7) of the Teaching and Higher Education Act 1998(a) and now vested in the National Assembly for Wales(b), the National Assembly for Wales, being of the opinion that the General Teaching Council for Wales may, having regard to their general objectives, appropriately discharge the additional functions hereby conferred and having carried out such consultation as appears to it to be appropriate, makes the following Order:

Enw a chychwyn

1. Enw'r Gorchymyn hwn yw Gorchymyn Cyngor Addysgu Cyffredinol Cymru (Swyddogaethau Ychwanegol) (Diwygio) 2001 a daw i rym ar 1 Awst 2001.

Citation and commencement

1. This Order is called the General Teaching Council for Wales (Additional Functions) (Amendment) Order 2001 and shall come into force on 1st August 2001.

2. Mae Gorchymyn Cyngor Addysgu Cyffredinol Cymru (Swyddogaethau Ychwanegol) 2000(c) yn cael ei ddiwygio fel a ganlyn -

(a) yn erthygl 3(2), ar ôl "Gorchymyn hwn", mewnosodir -

"am unrhyw gyfnod (os o gwbl) a bennir yn y Rhan honno ac"; a

(b) yn Rhan II o'r Atodlen, ar ôl paragraff 23, mewnosodir -

2. The General Teaching Council for Wales (Additional Functions) Order 2000(c) is amended as follows -

(a) in article 3(2), after "this Order", there shall be inserted -

"for such period (if any) as is specified in that Part and"; and

(b) in Part II of the Schedule, after paragraph 23 there shall be inserted -

23B. The terms of any reprimand issued by the Council or the General Teaching Council for England, for a period of two years from the date the reprimand was issued."
