Mae'r Gorchymyn hwn yn diwygio Gorchymyn Iechyd Planhigion (Prydain Fawr) 1993 er mwyn rhoi Cyfarwyddebau'r Comisiwn 2001/32/EC (OJ Rhif L127, 9.5.2001, t.38) a 2001/33/EC (OJ Rhif L127, 9.5.2001, t.42) ar waith yng Nghymru. Mae'r cyntaf o'r ddwy yn diwygio'r parthau diogel a sefydlwyd o dan y prif Gyfarwyddeb Iechyd Planhigion, Cyfarwyddeb y Cyngor 2000/29/EC (OJ Rhif L169, 10.7.2000, t.1) ac mae'r ail yn darparu ar gyfer diwygiadau canlyniadol i rai o Atodiadau'r Gyfarwyddeb honno.

Mae'r Gorchymyn yn gwneud sawl newid i ddiffiniadau daearyddol amrywiol barthau diogel a restrir yn Atodlen 8 i Orchymyn 1993 a diwygiadau cyfatebol i Atodlenni 1B, 2B, 3B a 4B. Mae'n dileu o Atodlen 8 y parth diogel mewn perthynas â'r pla *Pissodes* spp. (Ewropeaidd). Gwneir diwygiadau daearyddol eraill i'r parthau a ddiffinnir yn Atodlen 8, gan gynnwys tynnu Denmarc o'r parthau diogel mewn perthynas â *Bemisia tabaci* Genn. (poblogaethau Ewropeaidd) a firws clefyd gwywo brith Tomato; yn adlewyrchu ailddiffinio ffiniau llywodraeth leol yn Sweden mewn perthynas â'r pla *Leptinotarsa decemlineata* Say; ac yn adlewyrchu dosbarthiad presennol yr organeddau *Erwinia amylovora* (Burr.) Winsl. Et al. yn Ffrainc, yr Eidal ac Awstria, a *Gonipterus scutellatus* Gyll. yn Mhortiwgal.

Ceir y diwygiadau sy'n rhoi Cyfarwyddeb 2001/33/EC ar waith yn erthygl 2(4) i 2(8) yn gynwysedig ac yn erthygl 2(11), a cheir y rhai sy'n rhoi Cyfarwyddeb 2001/32/EC ar waith yn erthygl 2(12) i 2(14) yn gynwysedig.

The Plant Health (Amendment)  
(Wales) (No.2) Order 2001

#### EXPLANATORY NOTE

*(This note is not part of the Order)*

This Order amends the Plant Health (Great Britain) Order 1993 so as to implement Commission Directives 2001/32/EC (OJ No. L127, 9.5.2001, p.38) and 2001/33/EC (OJ No. L127, 9.5.2001, p.42) in Wales. The former Directive amends the protected zones established under the principal Plant Health Directive, Council Directive 2000/29/EC (OJ No. L169, 10.7.2000, p.1) and the latter provides for consequential amendments to certain Annexes of that Directive.

The Order makes several changes to the geographical definitions of various protected zones listed in Schedule 8 to the 1993 Order and corresponding amendments to Schedules 1B, 2B, 3B and 4B. It deletes from Schedule 8 the protected zone in respect of the pest *Pissodes* spp. (European). Other geographical amendments are made to the zones defined in Schedule 8, including removing Denmark from the protected zones in respect of *Bemisia tabaci* Genn. (European populations) and Tomato spotted wilt virus; reflecting local government boundary redefinitions within Sweden in respect of the pest *Leptinotarsa decemlineata* Say; and reflecting the present distribution of the organisms *Erwinia amylovora* (Burr.) Winsl. Et al. in France, Italy and Austria, and *Gonipterus scutellatus* Gyll. in Portugal.

The amendments implementing Directive 2001/33/EC are at article 2(4) to 2(8) inclusive and at article 2(11), and those implementing Directive 2001/32/EC are at article 2(12) to 2(14) inclusive.

Mae'r Gorchymyn hefyd yn diweddu cyfeiriadau at y brif ddeddfwriaeth Ewropeaidd, gan adlewyrchu'r cydgrynhau a'r diddymu diweddar ar Gyfarwyddeb 77/93/EEC sydd wedi'i disodli gan Gyfarwyddeb 2000/29/EC. Ceir y diwygiadau hyn yn erthygl 2(2) a 2(3), 2(9) a 2(10) ac yn 2(15) a 2(16) o'r Gorchymyn.

The Order also updates the references to the principal European legislation, reflecting the recent consolidation and repeal of Directive 77/93/EEC which has been replaced by Directive 2000/29/EC. Those amendments are contained at article 2(2) and 2(3), 2(9) and 2(10) and at 2(15) and 2(16) of the Order.

The National Assembly for Wales, in exercise of the powers conferred by sections 2, 3 and 4(1) of the Plant Health Act 1967(a) as read with section 20 of the Agriculture (Miscellaneous Provisions) Act 1972(b) and now vested in the National Assembly for Wales(c)makes the following Order.

**Title, application and commencement**

1. This Order may be cited as the Plant Health (Amendment) (Wales) (No.2) Order 2001, shall extend to Wales only, and shall come into force on 17 December 2001.

**Amendment of the Plant Health (Great Britain) Order 1993**

2.-(1) The Plant Health (Great Britain) Order 1993(d) shall be amended in accordance with paragraphs (2) to (16) below.

(a) 1967 c.8; sections 2(1) and 3(1) and (2) were amended by the European Communities Act 1972 (c.68), section 4(1) and Schedule 4, paragraph 8; section 3(4) was substituted by section 42 of the Criminal Justice Act 1982 (c.48);

(b) 1972 c.62.

(c) Section 1(2)(b) of the Plant Health Act 1967 provides that the competent authority in England and Wales for the purposes of that Act is the Minister of Agriculture, Fisheries and Food. By virtue of the Transfer of Functions (Wales) (No. 1) Order 1978 (S.I. 1978/272), article 2(1) and Schedule 1, the functions of the Minister of Agriculture, Fisheries and Food under the Plant Health Act 1967 were, so far as they are exercisable in relation to Wales, transferred to the Secretary of State. These functions of the Secretary of State for Wales were then transferred to the National Assembly for Wales by the National Assembly for Wales (Transfer of Functions) Order 1999 (S.I. 1999/672).

(d) at item 24, in the third column, "DK" shall be deleted.

(12) Schedule 8(a) (Insects, Mites and Nematodes, at All Stages of Their Development) shall be amended as follows -

(a) at item 2, in the second column, "Denmark" shall be deleted;

(b) at item 6, for the text in the second column there shall be substituted the following text:

"Greece, Portugal (Azores; district of Beja: all concelhos; district of Castelo Branco: concelhos de Castelo Branco, Fundão and Penamacôr, Idanha-a-Nova; district of Évora with the exception of concelhos de Montemor-o-Novo, Mora and Vendas Novas; district of Faro: all concelhos; district of Portalegre: concelhos de Arronches, Campo Maior, Elvas, Fronteira, Monforte and Sousel)";

(c) at item 12, the text in the second column shall be deleted and replaced by the following text:

"Spain (Ibiza and Menorca), Ireland, Portugal (Azores and Madeira), Finland (districts of Åland, Håme, Kymi, Pirkanmaa, Satakunta, Turku, Uusimaa), Sweden (counties of Blekinge, Gotlands, Halland, Kalmar and Skåne), United Kingdom"; and

(d) item 14 shall be deleted

(13) In Schedule 8(b) (Bacteria), at item 2 for the text in the second column there shall be substituted the following text:

"Spain, France (Corsica), Ireland, Italy (Abruzzi; Basilicata; Calabria; Campania; Emilia-Romagna: provinces of Forlì-Cesena, Parma, Piacenza and Rimini; Friuli-Venezia Giulia; Lazio; Liguria; Lombardy; Marche; Molise; Piedmont; Apulia; Sardinia; Sicily; Tuscany; Trentino-Alto Adige: autonomous provinces of Bolzano and Trento; Umbria; Valle d'Aosta; Veneto), Austria (Burgenland, Carinthia, Lower Austria, East Tyrol, Styria, Vienna), Portugal, Finland, United Kingdom (Northern Ireland, Isle of Man and Channel Islands)".

(14) In Schedule 8(d) (Viruses and Virus-like Organisms), at item 2 in the second column, "Denmark" shall be deleted.

(15) In Schedule 13, paragraph 9(1)(a), for "Council Directive 77/93/EEC" there shall be substituted the words "Council Directive 2000/29/EC".

(16) Schedule 16 (Instruments Amending and Supplementing Council Directive 77/93/EEC) shall be deleted.
