Mae'r Rheoliadau hyn yn diwygio'r ffurflenni (dwyieithog) sydd i'w defnyddio i wneud cais am grant adleoli o dan adrannau 131 i 140 o Ddeddf Grantiau Tai, Adeiladu ac Adfywio 1996.

These Regulations amend the (bilingual) forms to be used for an application for a relocation grant under sections 131 to 140 of the Housing Grants, Construction and Regeneration Act 1996.

Mae'r ffurflen Gymraeg sy'n cael ei diwygio wedi'i nodi yn yr Atodlen i Reoliadau Grantiau Adleoli (Ffurflen Gais) (Ffurflen Gais Gymraeg) 1999 (O.S. 1999/2315 fel y'i diwygiwyd).

The Welsh language form amended is set out in the Schedule to the Relocation Grants (Form of Application) (Welsh Form of Application) Regulations 1999 (S.I. 1999/2315 as amended).

Mae'r ffurflen Saesneg sy'n cael ei diwygio wedi'i nodi yn yr Atodlen i Reoliadau Grantiau Adleoli (Ffurflen Gais) 1997 (O.S. 1997/2847 fel y'i diwygiwyd).

The English language form amended is set out in the Schedule to the Relocation Grants (Form of Application) Regulations 1997 (S.I. 1997/2847 as amended).

Mae Rheoliadau Grantiau Adleoli 1997 (O.S. 1997/2764) yn cymhwyso Rheoliadau Grantiau Adnewyddu Tai 1996 (O.S. 1996/2890) fel y maent yn effeithiol o dro i dro, gyda'r newidiadau sydd wedi'u rhagnodi. Gan hynny, mae diwygiadau i Reoliadau Grantiau Adnewyddu Tai 1996 gan Reoliadau Grantiau Adnewyddu Tai (Diwygio Rhif 2) (Cymru) 2001 (O.S. 2001/4007 (Cy.333)) wedi'i gwneud yn angenrheidiol diwygio'r ffurflenni, a'r Rheoliadau hyn sy'n gwneud y diwygiadau angenrheidiol.

The Relocation Grants Regulations 1997 (S.I. 1997/2764), apply the Housing Renewal Grants Regulations 1996 (S.I. 1996/2890) as they have effect from time to time, with the modifications prescribed. Amendments to the Housing Renewal Grants Regulations 1996 by the Housing Renewal Grants (Amendment No. 2) (Wales) Regulations 2001 (S.I. 2001/4007 (W.333)) have accordingly necessitated amendments to the forms, and these Regulations make the necessary amendments.

Mae'r diwygiadau'n ymwneud â thaliadau arbennig a delir i ddiodefwrwr amrywiolyn clefyd Creutzfeldt-Jakob a'u teuluoedd agos.

The amendments relate to special payments made to sufferers of variant Creutzfeldt-Jakob disease and their immediate families.

The National Assembly for Wales, in exercise of the powers conferred upon it by sections 132(3) and (4)(a) and 146(1) and (2) of the Housing Grants, Construction and Regeneration Act 1996(b) as extended by section 26(3) of the Welsh Language Act 1993(c) makes the following Regulations:

1.-(1) Enw'r Rheoliadau hyn yw Rheoliadau Grantiau Adleoli (Ffurflenni Cais) (Diwygio Rhif 2) (Cymru) 2001 a deuant i rym ar 11 Ionawr 2002.

1.-(1) These Regulations are called the Relocation Grants (Forms of Application) (Amendment No. 2) (Wales) Regulations 2001 and they shall come into force on 11th January 2002.

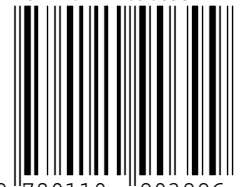
