Mae'r Rheoliadau hyn yn diwygio Rheoliadau Addysg (Cyraeddiadau Disgyblion Unigol) (Gwybodaeth) (Cymru) 1997 o ganlyniad i newidiadau i'r Cwricwlwm Cenedlaethol a ddaeth i rym ym mis Awst 2000. Cyn y newidiadau hynny, nid oedd darpariaeth ar gyfer mesur lefelau cyrhaeddiad disgyblion mewn celf, cerddoriaeth ac addysg gorfforol yng nghyfnod allweddol 3 drwy gyfrwng graddfa ffurfiol. Yn hytrach, i fesur cyraeddiadau disgyblion yng nghyfnod allweddol 3, yr oedd y Cwricwlwm Cenedlaethol yn cynnwys yr hyn a elwid "Disgrifiadau diwedd cyfnod allweddol" ar gyfer pob targed cyrhaeddiad. O dan y Cwricwlwm Cenedlaethol newydd, mae yna ddarpariaeth erbyn hyn ar gyfer mesur lefel cyrhaeddiad disgyblion yn y pynciau hyn drwy gyfrwng graddfa. Mae'r diwygiadau a wneir yn sgil y Rheoliadau hyn i Reoliadau 1997 yn adlewyrchu'r newidiadau hyn.

The Education (Individual Pupils' Achievements) (Information) (Wales) (Amendment) Regulations 2001

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations amend the Education (Individual Pupils' Achievements) (Information) (Wales) Regulations 1997 in the light of changes to the National Curriculum which came into effect in August 2000. Before those changes, there was no provision for measuring, by means of a formal scale, pupils' levels of attainment in art, music and physical education at key stage 3. Instead, for the purpose of measuring pupils' achievements at key stage 3, the National Curriculum contained what were termed "End of key stage descriptions" for each attainment target. Under the new National Curriculum provision is now made for measuring pupils levels of attainment in those subjects by means of a scale. The amendments which these Regulations make to the 1997 Regulations simply reflect those changes.

2.-(1) Mae Rheoliadau Addysg (Cyraeddiadau Disgyblion Unigol) (Gwybodaeth) (Cymru) 1997(c) yn cael eu diwygio fel a ganlyn.

(2) Yn rheoliad 3(10), hepgorwch is-baragraff (c).

(3) Yn rheoliad 6(2), hepgorwch “(other than art, music and physical education)” yn is-baragraff (a) a'r cyfan o is-baragraff (b).

(4) Ym mharagraff 3 o Atodlen 1, hepgorwch “(other than art, music and physical education)” yn is-baragraff (1) a'r cyfan o is-baragraff (2).

The Education (Individual Pupils' Achievements) (Information) (Wales) (Amendment) Regulations 2001

Coming into force

1st April 2001

The National Assembly for Wales, there being no persons with whom it appeared to it that consultation would be desirable, makes the following Regulations in exercise of the powers conferred by sections 408 and 569(4) and (5) of the Education Act 1996(a) and now vested in the National Assembly for Wales(b).

Citation and commencement

1. These Regulations are called the Education (Individual Pupils' Achievements) (Information) (Wales) (Amendment) Regulations 2001 and come into force on 1st April 2001.

Amendment of Regulations

2.-(1) The Education (Individual Pupils' Achievements) (Information) (Wales) Regulations 1997(c) are amended as follows.

(2) In regulation 3(10), omit sub-paragraph (c).

(3) In regulation 6(2), omit “(other than art, music and physical education)” in sub-paragraph (a) and the whole of sub-paragraph (b).

(4) In paragraph 3 of Schedule 1, omit “(other than art, music and physical education)” in sub-paragraph (1) and the whole of sub-paragraph (2).
