EXPLANATORY NOTE

Mae'r Rheoliadau hyn, sy'n gymwys i Gymru yn unig, yn ychwanegu crancod at y mathau o bysgod cregyn sy'n dod o dan adran 1(1) o Ddeddf Pysgodfeydd Môr (Pysgod Cregyn) 1967 ("Deddf 1967"). Mae hyn yn ei gwneud hi'n bosibl i sefydlu pysgodfeydd crancod unigol neu bysgodfeydd crancod wedi'u rheoleiddio drwy orchmynion o dan yr adran honno.

Pennwyd cregyn bylchog a chwiniad at ddben adran 1 o Ddeddf 1967 gan Reoliadau Pysgod Cregyn (Dynodi Molysgiaid) 1987 (O.S. 1987/218).

These Regulations, which apply only in relation to Wales, add crabs to the types of shellfish falling within section 1(1) of the Sea Fisheries (Shellfish) Act 1967 ("the 1967 Act"). This enables several or regulated fisheries for crabs to be established by orders under that section.

Scallops and queens were specified for the purpose of section 1 of the 1967 Act by the Shellfish (Specification of Molluscs) Regulations 1987 (S.I. 1987/218).

Mae Cynulliad Cenedlaethol Cymru, drwy arfer y pwerau a roddwyd iddo gan adran 1(1) o Ddeddf Pysgodfeydd Môr (Pysgod Cregyn) 1967(a) a phob pŵer arall sy'n ei alluogi yn hynny o beth, drwy hyn yn gwneud y Rheoliadau canlynol:

The National Assembly for Wales, in exercise of the powers conferred on it by section 1(1) of the Sea Fisheries (Shellfish) Act 1967(a) and of all other powers enabling it in that behalf, hereby makes the following Regulations:

Enwi, cychwyn a chymhwyso**Title, commencement and application**

1.-(1) Enw'r Rheoliadau hyn yw Rheoliadau Pysgod Cregyn (Dynodi Cramenogion) (Cymru) 2002 a deuant i rym ar 5 Awst 2002.

1.-(1) These Regulations are called the Shellfish (Specification of Crustaceans) (Wales) Regulations 2002 and come into force on 5th August 2002.

(2) Mae'r Rheoliadau hyn yn gymwys i Gymru ac i'r môr gerllaw Cymru hyd at ffin forol y môr tiriogaethol.

(2) These Regulations apply to Wales and the sea adjacent to Wales out as far as the seaward boundary of the territorial sea.

2. Pennir drwy hyn grancod at ddibenion adran 1(1) o Ddeddf Pysgodfeydd Môr (Pysgod Cregyn) 1967.

2. Crabs are hereby specified for the purposes of section 1(1) of the Sea Fisheries (Shellfish) Act 1967.

Trosglwyddwyd swyddogaethau'r "Gweinidog priodol" mewn perthynas â Chymru i Gynulliad Cenedlaethol Cymru gan Orchymyn Cynulliad Cenedlaethol Cymru (Trosglwyddo Swyddogaethau) 1999 (O.S. 1999/672), Erthygl 2 ac Atodlen 1.
