O dan adran 64(1) o Ddeddf Llywodraeth Leol 1972 (fel y'i hamnewidwyd gan Ddeddf Llywodraeth Leol (Cymru) 1994) yr oedd yn ofynnol i Gomisiwn Ffiniau Llywodraeth Leol Cymru adolygu'r trefniadau etholiadol cyn gynted â phosibl ar ôl yr etholiadau cyntaf i'r awdurdodau unedol ym Mai 1995.

The Local Government Boundary Commission for Wales was required by section 64(1) of the Local Government Act 1972 (as substituted by the Local Government (Wales) Act 1994) to review electoral arrangements as soon as practicable after the first elections to unitary authorities in May 1995.

Mae'r Gorchymyn hwn yn rhoi ei effaith i'r cynigion a wnaed yn adroddiad Mawrth 2000 Comisiwn Ffiniau Llywodraeth Leol Cymru ar gyfer Sir Fynwy.

This Order gives effect to the proposals made in the Local Government Boundary Commission for Wales' report of March 2000 for the County of Monmouthshire.

Er bod y Gorchymyn yn diddymu'r holl adrannau etholiadol presennol yn y Sir ac yn eu disodli ag adrannau etholiadol newydd, yn ymarferol bydd y mwyafrif ohonynt yn aros yr un fath.

Although the Order abolishes all existing electoral divisions within the County and replaces them with new electoral divisions, in practice the majority of them will remain the same.

**Croesonen, Crucorney, Goetre Fawr, Larkfield, Llanbadoc, Llanelly Hill, Llanfoist Fawr, Llanybi Fawr, Llanover, Llantilio Crossenny, Llanwenarth Ultra, Mardy, Mitchel Troy, Overmonnow, Portskewett, Raglan, Rogiet, St. Arvans, St. Christopher's, St. Kingsmark, St. Mary's, Thornwell, Trellech United, Usk, Wyesham.**

Mae cymuned bresennol y **Fenni** i'w rhannu i greu pum adran etholiadol y bydd pob un ohonynt yn ethol un cynghorydd:

The existing community of **Abergavenny** is to be divided to create five electoral divisions each returning one councillor:

**Cantref, Y Castell, Grofield, Lansdown, Y Priordy.**

**Cantref, Castle, Grofield, Lansdown, Priory.**

Mae cymuned bresennol **Caldicot** i'w rhannu i greu pum adran etholiadol y bydd pob un ohonynt yn ethol un cynghorydd:

**Castell Caldicot, Dewstow, Green Lane, Hafren, West End.**

Ar hyn o bryd mae adran bresennol **Caer-went** yn cynnwys Cymunedau Caer-went a Matharn. O dan y trefniadau newydd bydd adran etholiadol Caer-went yn cynnwys Cymuned Caer-went. Bydd yr adran yn ethol un cynghorydd.

Ar hyn o bryd mae adran bresennol **Drenewydd Gelli-farch** yn cynnwys Cymunedau Devauden, Llangwm a Drenewydd Gelli-farch. O dan y trefniadau newydd mae **Drenewydd Gelli-farch** yn cynnwys Cymunedau **Matharn** a **Drenewydd Gelli-farch** ac yn ethol un cynghorydd.

Mae adrannau etholiadol newydd yn cael eu creu ar gyfer:

**Devauden**, sy'n ethol un cynghorydd. Mae'r adran i gynnwys cymunedau **Devauden** a **Llan-gwm**.

Mae **Dixton gydag Osbaston** i ethol un cynghorydd. Mae'r adran i gynnwys ward **Dixton gydag Osbaston** yng Nghymuned Trefynwy.

**Drybridge**, sy'n ethol un cynghorydd. Mae'r adran i gynnwys ward **Drybridge** a ward y **Dref** yng Nghymuned Trefynwy.

**Mill**, sy'n ethol un cynghorydd. Mae'r adran i gynnwys wardiau **The Mill, Denny** and **Salisbury** yng Nghymuned **Magwyr gyda Gwndy**.

**The Elms**, sy'n ethol un cynghorydd. Mae'r Adran i gynnwys ward **The Elms** yng Nghymuned **Magwyr gyda Gwndy**.

Mae ardaloedd yr adrannau newydd wedi'u diffinio ar y map manwl a ddisgrifir yn Erthygl 2, ac y gellir archwilio printiau ohono ar bob adeg resymol yn swyddfeydd y Cyngor Sir ac yn swyddfeydd Cynulliad Cenedlaethol Cymru, Parc Cathays, Caerdydd, CF10 3NQ (Yr Is-adran Moderneiddio Llywodraeth Leol).

The existing community of **Caldicot** is to be divided to create five electoral divisions each returning one councillor:

**Caldicot Castle, Dewstow, Green Lane, Severn, West End.**

The existing division of **Caerwent** presently includes the communities of Caerwent and Matharn. Under the new arrangements the electoral division of Caerwent comprises of the Community of Caerwent. The division will return one councillor.

The existing division of **Shirenewton** presently comprises the communities of Devauden, Llangwm and **Shirenewton**. Under the new arrangements the electoral division of **Shirenewton** comprises of the communities of **Mathern** and **Shirenewton** and returns one councillor.

New electoral divisions are created for:

**Devauden**, returning one councillor. The division to comprise of the communities of **Devauden** and **Llangwm**.

**Dixton with Osbaston** to return one councillor. The division to comprise of the **Dixton with Osbaston** ward of the Community of Monmouth.

**Drybridge**, returning one councillor. The division to comprise of the **Drybridge** and **Town** wards of the Community of Monmouth.

**Mill**, returning one councillor. The division to comprise of **The Mill, Denny** and **Salisbury** wards of the Community of **Magor with Undy**.

**The Elms**, returning one councillor. The division to comprise of **The Elms** ward of the Community of **Magor with Undy**.

The areas of the new divisions are demarcated on the detailed map described in Article 2, prints of which may be inspected at all reasonable times at the offices of Monmouthshire County Council and at the offices of the National Assembly for Wales, Cathays Park, Cardiff, CF10 3NQ (Local Government Modernisation Division).

Yn unol ag adrannau 58(1) a 64 o Ddeddf Llywodraeth Leol 1972(a) cyflwynodd Comisiwn Ffiniau Llywodraeth Leol Cymru gynigion ym Mawrth 2000 ar gyfer trefniadau etholiadol y dyfodol ar gyfer Sir Fynwy. Mae Cynulliad Cenedlaethol Cymru, gan ei fod wedi cytuno â'r cynigion, yn gwneud y Gorchymyn canlynol drwy arfer y pwerau a roddwyd iddo gan adrannau 58(2) a 67(4) a (5) o'r Ddeddf.

In pursuance of sections 58(1) and 64 of the Local Government Act 1972(a) the Local Government Boundary Commission for Wales submitted proposals in March 2000 for the future electoral arrangements for the County of Monmouthshire. The National Assembly for Wales, having agreed with the proposals, makes the following Order in exercise of the powers conferred on it by sections 58(2) and 67(4) and (5) of the Act.

(2) At ddibenion ethol cynghorwyr ar gyfer Sir Fynwy, rhennir y Sir honno yn 42 o adrannau etholiadol yn dwyn yr enwau a bennir yng ngholofn (1) o'r Atodlen i'r Gorchymyn hwn, a bydd pob adran etholiadol o'r fath yn ffurfio'r ardal a bennir yng ngholofn (2) o'r Atodlen honno, fel y'i dynodir ar y map ac fel y'i diffinnir â llinellau coch.

### **Electoral Divisions**

2.-(1) The existing electoral divisions of the County of Monmouthshire specified in the Schedule to the County of Monmouthshire Electoral Arrangements Order 1994 are abolished.

(2) For the purposes of the elections of councillors for the County of Monmouthshire, that County shall be divided into 42 electoral divisions bearing the names specified in column (1) of the Schedule to this order, and each such electoral division shall comprise the area specified in column (2) of that Schedule, as designated on the map and demarcated by red lines.

(3) The number of councillors to be returned for each such electoral division shall be the number specified in relation to the division in column (3) of the Schedule to this Order.

### **Register of Local Government Electors**

3. The registration officer shall make such re-arrangements or adaptation of the register of local government electors as may be necessary due to the coming into force of this Order.
