EXPLANATORY NOTE

(Nid yw'r nodyn hwn yn rhan o'r Rheoliadau)

(This note does not form part of the Regulations)

Mae'r Rheoliadau hyn, sy'n gymwys i Gymru yn unig, yn diwygio Rheoliadau Ychwanegion Bwyd Amrywiol 1995, fel y'u diwygiwyd eisoes ("y prif Reoliadau") sy'n gymwys i Brydain Fawr.

These Regulations, which apply to Wales only, amend the Miscellaneous Food Additives Regulations 1995, as already amended ("the principal Regulations"), which extend to Great Britain.

Mae'r Rheoliadau yn gweithredu -

The Regulations implement -

- (a) Cyfarwyddeb y Comisiwn 2001/30/EC sy'n diwygio Cyfarwyddeb 96/77/EC sy'n nodi meini prawf purdeb penodol ar ychwanegion bwyd heblaw lliwiau a melysyddion (OJ Rhif L146, 31.5.2001, t.1), a
- (b) Cyfarwyddeb 2001/5/EC y Senedd Ewropeaidd a'r Cyngor sy'n diwygio Cyfarwyddeb 95/2 ar ychwanegion bwyd heblaw lliwiau a melysyddion (OJ Rhif L55, 24.2.2001, t.59).

- (a) Commission Directive 2001/30/EC amending Directive 96/77/EC laying down specific purity criteria on food additives other than colours and sweeteners (OJ No. L146, 31.5.2001, p. 1), and
- (b) Directive 2001/5/EC of the European Parliament and of the Council amending Directive 95/2 on food additives other than colours and sweeteners (OJ No. L55, 24.2.2001, p.59).

Yn ddarostyngedig i ddarpariaeth drosiannol, mae'r Rheoliadau'n pennu meini prawf purdeb newydd mewn perthynas â'r ychwanegion a bennir yn yr Atodiad i gyfarwyddeb y Comisiwn 2001/30/EC (rheoliadau 3(b) ac (c), 4 ac 8) ac yn gwneud diwygiadau i Reoliadau penodol o ran cyfeiriadau yn y Rheoliadau hynny at y prif Reoliadau (rheoliad 9).

Subject to a transitional provision, the Regulations specify new purity criteria in relation to the additives specified in the Annex to Commission Directive 2001/30/EC (regulations 3(b) and (c), 4 and 8) and make related amendments to certain Regulations as regards references in those Regulations to the principal Regulations (regulation 9).

Mae'r Rheoliadau hefyd -

The Regulations also -

- (a) yn ychwanegu un ychwanegyn newydd at y rhestr, yn Atodlen 1 i'r prif Reoliadau, o ychwanegion bwyd amrywiol y caniateir yn gyffredinol eu defnyddio mewn bwydydd na chyfeirir atynt yn Atodlen 6, 7 neu 8 i'r Rheoliadau hynny (rheoliad 5);

- (a) add one new additive to the list, in Schedule 1 to the principal Regulations, of miscellaneous food additives generally permitted for use in foods not referred to in Schedule 6, 7 or 8 to those Regulations (regulation 5);

- (b) yn addasu'r rhestr, yn Atodlen 3 i'r prif Reoliadau, o ychwanegion bwyd amrywiol a all gael eu cynnwys mewn bwydydd penodol, drwy ychwanegu pedwar ychwanegyn newydd at y rhestr honno a phennu bwydydd ychwanegol y gellir cynnwys esterau Glycerol o rosinau coed ynddynt (rheoliad 6); ac
 - (c) yn addasu'r rhestr o garwyr a thoddyddion carwyr a ganiateir yn Atodlen 1 i'r prif Reoliadau drwy ymgorffori Rhif E ar gyfer Propan - 1,2-diol (propylene glycol) (rheoliad 7).
- (b) modify the list, in Schedule 3 to the principal Regulations, of miscellaneous food additives which may be included in certain foods, by adding four new additives to that list and specifying additional foods in which Glycerol esters of wood rosins may be contained (regulation 6); and
 - (c) modify the list of permitted carriers and carrier solvents in Schedule 4 to the principal Regulations by incorporating an E Number for Propan - 1,2-diol (propylene glycol) (regulation 7).

Drwy arfer y pwerau a roddir gan adrannau 16(1)(a), 17(1), 26(1) a (3) a 48(1) o Ddeddf Diogelwch Bwyd 1990(a), a pharagraff 1 o Atodlen 1 iddi, sydd bellach wedi'u breinio yng Nghynulliad Cenedlaethol Cymru(b), mae Cynulliad Cenedlaethol Cymru, ar ôl rhoi sylw yn unol ag adran 48(4A) o'r Ddeddf honno i gyngor perthnasol a roddwyd gan yr Asiantaeth Safonau Bwyd ac ar ôl ymgynghori yn unol ag adran 48(4) a (4B) o'r Ddeddf honno, yn gwneud y Rheoliadau canlynol:

In exercise of the powers conferred by sections 16(1)(a), 17(1), 26(1) and (3) and 48(1) of, and paragraph 1 of Schedule 1 to, the Food Safety Act 1990(a), and now vested in the National Assembly for Wales(b), the National Assembly for Wales, having had regard, in accordance with section 48(4A) of that Act to relevant advice given by the Food Standards Agency and after consultation in accordance with section 48(4) and (4B) of that Act, makes the following Regulations:

1.-(1) These Regulations may be cited as the Miscellaneous Food Additives (Amendment) (Wales) Regulations 2002.

(2) Mae'r Rheoliadau hyn yn gymwys i Gymru yn unig a deuant i rym ar 1 Mawrth 2002.

(2) These Regulations apply to Wales only and come into force on 1st March 2002.

"(1D) In any proceedings for an offence under these Regulations in respect of any food additive or food, it shall be a defence to prove that -

(a) the food additive or food concerned was put on the market or labelled before 1 March 2002; and

(b) the matter constituting the offence would not have constituted an offence under these Regulations if the amendments made by regulations 3 (b) and (c) and 8 of the Miscellaneous Food Additives (Amendment) (Wales) Regulations 2002 had not been in force when that matter occurred."

5. In Schedule 1 (miscellaneous additives generally permitted for use in foods not referred to in Schedule 6, 7 or 8) -

(a) in note (2), for the words "and E 948" there shall be substituted the words ", E 948 and E 949"; and

(b) in the Table -

(i) in the first column, immediately after the reference to "E948", there shall be inserted a reference to "E949", and

(ii) in the second column, immediately after the reference to "Oxygen", there shall be inserted a reference to "Hydrogen".

7. In Schedule 4 (permitted carriers and carrier solvents), in the entry for Propan - 1,2-diol (propylene glycol) there shall be inserted in the first column the reference "E 1520".

8. In Schedule 5 (purity criteria)-

(a) for the text at the start commencing with the words "Each miscellaneous additive for which specific purity criteria are specified" and ending with the expression "E 957 Thaumatin.", there shall be substituted the following text -

"The miscellaneous additives for which specific purity criteria are referred to below shall not contain -

(a) more than 2 milligrams per kilogram of arsenic;

(b) more than 10 milligrams per kilogram of lead;

- (b) the remainder of the Schedule shall be omitted save for the provisions relating to magnesium carbonates (E 504).

Amendment of the Miscellaneous Food Additives (Amendment) (Wales) Regulations 2001

9. - (1) Paragraph (2) of regulation 6 (consequential amendments) of the Miscellaneous Food Additives (Amendment) (Wales) Regulations 2001(a) shall be omitted.

(2) In the Regulations listed below, in so far as they extend to Wales, references to the Miscellaneous Food Additives Regulations 1995 shall be constructed as references to those Regulations as amended by the Miscellaneous Food Additives (Amendment) Regulations 1997(b), the Miscellaneous Food Additives (Amendment) Regulations 1999(c), the Coffee Extracts and Chicory Extracts (Wales) Regulations 2001(d), the Miscellaneous Food Additives (Amendment) (Wales) Regulations 2001(e) and these Regulations:

the Mineral Hydrocarbons in Food Regulations 1966(f); the Specified Sugar Products Regulations 1976(g); the Cocoa and Chocolate Products Regulations 1976(h); the Fruit Juices and Fruit Nectars Regulations 1977(i); the Condensed Milk and Dried Milk Regulations 1977(j); the Jam and Similar Products Regulations 1981(k); the Meat Products and Spreadable Fish Products Regulations 1984(l); the Food Additives Labelling Regulations 1992(m); the Food Labelling Regulations 1996(n).
