Mae'r Rheoliadau hyn yn diwygio ymhellach Reoliadau'r Gwasanaeth Iechyd Gwladol (Ffioedd a Thaliadau Optegol) 1997 ("Rheoliadau 1997") a Rheoliadau'r Gwasanaeth Iechyd Gwladol (Gwasanaethau Offthalmig Cyffredinol) 1986 ("Rheoliadau 1986").

Mae Rheoliadau 1997 yn darparu ar gyfer cynllun taliadau sydd i'w gwneud gan Awdurdodau Iechyd ac Ymddiriedolaethau'r GIG trwy gyfrwng system dalebau mewn perthynas â chostau a dynnir gan gategorïau penodol o bersonau mewn cysylltiad â phrofion llygaid, ac â chyflenwi, ailosod a thrwsio teclynnau optegol.

Mae Rheoliadau 1986 yn cynnwys darpariaeth ar gyfer trefnu gwasanaethau offthalmig cyffredinol o dan y Gwasanaeth Iechyd Gwladol.

Mae'r newidiadau a wneir gan y Rheoliadau hyn yn cyflwyno yn y categorïau o bersonau y mae ganddynt yr hawl i dderbyn cymorth tuag at gost cyflenwi teclynnau optegol (o dan Reoliadau 1997) ac i gael prawf llygaid o dan wasanaethau offthalmig cyffredinol (o dan Reoliadau 1986) aelodau o deulu y mae ei incwm yn disgyn o dan y terfyn penodedig ac sy'n derbyn credyd treth gwaith gydag elfen anabledd difrifol.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations further amend the National Health Service (Optical Charges and Payments) Regulations 1997 ("the 1997 Regulations") and the National Health Service (General Ophthalmic Services) Regulations 1986 ("the 1986 Regulations").

The 1997 Regulations provide for a scheme of payments to be made by Health Authorities and NHS Trusts by means of a voucher system in respect of costs incurred by certain categories of persons in connection with sight tests and the supply, replacement and repair of optical appliances.

The 1986 Regulations contain provision for the arrangements for general ophthalmic services under the National Health Service.

The changes made by these Regulations introduce into the categories of persons entitled to receive assistance towards the cost of supply of optical appliances (under the 1997 Regulations) and to receive a sight test under general ophthalmic services (under the 1986 Regulations) members of a family whose income falls below a specified limit and which is in receipt of working tax credit with a severe disability element.

Pwrpas y diwygiadau yw sicrhau y bydd gan y rheini sy'n derbyn credyd gwarant credyd pensiwn ac aelodau o'u teuluoedd yr hawl i gael talebau'r Gwasanaeth Iechyd Gwladol i'w rhoi tuag at gost teclynnau optegol a gwasanaethau offthalmig cyffredinol.

Mae rheoliad 4 yn diwygio rheoliad 19 o Reoliadau 1997 (gwerth adbrynu taleb ar gyfer ailosod neu drwsio) er mwyn cynyddu gwerth taleb optegol a ddyroddir tuag at gost ailosod un lens gyffwrdd, a chynyddu mwyafswm y cyfraniad drwy daleb at gost trwsio ffrâm sbectol.

Mae rheoliad 5(1) yn diwygio Atodlen 1 o Reoliadau 1997 er mwyn cynyddu gwerth talebau a ddyroddir tuag at gostau cyflenwi ac ailosod sbectol a lensys cyffwrdd.

Mae rheoliad 5(2) yn diwygio Atodlen 2 i Reoliadau 1997 er mwyn cynyddu gwerthoedd ychwanegol y talebau ar gyfer prismau, arlliwiau, lensys ffotocromaidd a categoriâu arbennig o declynnau.

Mae rheoliad 5(3) a'r Atodlen yn rhoi Atodlen 3 newydd yn Rheoliadau 1997 i gynyddu gwerth y talebau a ddyroddir at drwsio ac ailosod teclynnau optegol.

Tua 2.5% yw graddfa'r cynnydd, ond ceir cynnydd o ryw 10% yng ngwerth talebau ar gyfer pobl benodol sydd â lensys presgripsiwn cryf.

Mae rheoliad 6 yn darparu na fydd y cynnydd yng ngwerth y talebau a wneir gan reoliadau 4 a 5 yn gymwys ond i dalebau a dderbynir neu a ddefnyddir ar ôl 1 Ebrill 2004.

They also make amendments consequent upon the introduction of pension credit guarantee credit in the State Pension Act 2002. The purpose of the amendments is to ensure that those in receipt of pension credit guarantee credit and members of their families will be entitled to National Health Service vouchers towards the cost of optical appliances and to general ophthalmic services.

Regulation 4 amends regulation 19 of the 1997 Regulations (redemption value of voucher for replacement or repair) to increase the value of an optical voucher issued towards the cost of replacing a single contact lens, and to increase the maximum contribution by way of a voucher to the cost of repairing a spectacle frame.

Regulation 5(1) amends Schedule 1 of the 1997 Regulations to increase the value of vouchers issued towards the costs of the supply and replacement of glasses and contact lenses.

Regulation 5(2) amends Schedule 2 to the 1997 Regulations to increase the additional values for vouchers for prisms, tints, photochromic lenses and special categories of appliances.

Regulation 5(3) and the Schedule substitute a new Schedule 3 in the 1997 Regulations to increase the value of vouchers issued towards the repair and replacement of optical appliances.

The rate of increase is approximately 2.5%, except that the value of vouchers for certain people with high prescription lenses is increased by approximately 10%.

Regulation 6 provides that the increases to the voucher values made by regulations 4 and 5 will only apply to vouchers accepted or used after 1 April 2004.

Citation, commencement, interpretation and application

1.-(1) These Regulations may be cited as the National Health Service (Optical Charges and Payments) and (General Ophthalmic Services) (Amendment) (Wales) Regulations 2004.

(2) Subject to paragraph (3) these Regulations will come into force on 1st April 2004.

(3) Regulations 2, 3, 7 and 8 will come into force on 6th April 2004.

(4) In these Regulations unless the context otherwise requires -

"the 1997 Regulations" ("Rheoliadau 1997") means the National Health Service (Optical Charges and Payments) Regulations 1997(a);

"the 1986 Regulations" ("Rheoliadau 1986") means the National Health Service (General Ophthalmic Services) Regulations 1986(b).

(5) These Regulations apply to Wales only.


