EXPLANATORY NOTE

(Nid yw'r nodyn hwn yn rhan o'r Rheoliadau)

(This note is not part of the Regulations)

Mae'r Rheoliadau hyn, a wnaed o dan adrannau 29(3), 408, 537, 537A(1) a (2) a 569(4) a (5) o Ddeddf Addysg 1996, yn gymwys mewn perthynas ag ysgolion yng Nghymru. Maent yn cydgyfnerthu, gyda diwygiadau, Rheoliadau Addysg (Gwybodaeth am Berfformiad Ysgolion) (Cymru) 1998, fel y'u diwygiwyd, ac yn eu dirymu.

These Regulations, made under sections 29(3), 408, 537, 537A(1) and (2) and 569(4) and (5) of the Education Act 1996, apply in relation to schools in Wales. They consolidate, with amendments, the Education (School Performance Information) (Wales) Regulations 1998, as amended, which are revoked.

Mae'r Rheoliadau'n ymwneud â chasglu gwybodaeth am berfformiad ysgolion.

The Regulations relate to the collection of information about the performance of schools.

Mae Rhan 1 o'r Rheoliadau yn cynnwys darpariaethau cyffredinol.

Part 1 of the Regulations comprises general provisions.

Mae Rhan 2 yn gosod dyletswyddau ar benaethiaid ysgolion a gynhelir i drefnu bod gwybodaeth ar gael i gyrff llywodraethu er mwyn eu galluogi i gydymffurfio â'u rhwymedigaethau o dan y Rheoliadau hyn (rheoliad 5).

Part 2 imposes duties on head teachers of maintained schools to make available information to governing bodies for the purpose of enabling them to comply with their obligations under these Regulations (regulation 5).

Mae Rhan 3 yn cynnwys darpariaethau manwl sy'n ymwneud â darparu gwybodaeth i Gynulliad Cenedlaethol Cymru ac i awdurdodau addysg lleol.

Part 3 contains detailed provisions relating to the provision of information to the National Assembly for Wales and to local education authorities.

Rhaid i gyrff llywodraethu ysgolion a gynhelir ddarparu gwybodaeth am ganlyniadau asesiadau ar y cyfnod allweddol cyntaf i'r awdurdodau addysg lleol (rheoliad 6 ac Atodlen 1).

Governing bodies of maintained schools must provide local education authorities with information about first key stage assessment results (regulation 6 and Schedule 1).

Rhaid i'r awdurdod addysg lleol roi gwybodaeth i Gynulliad Cenedlaethol Cymru am ganlyniadau asesiadau cyfnod allweddol cyntaf ar gyfer pob disgybl cofrestredig yng nghyfnod allweddol cyntaf yn yr ysgolion a gynhelir gan yr awdurdod (rheoliad 7 ac Atodlen 1).

The local education authority must provide the National Assembly for Wales with information about first key stage assessment results on all registered pupils in the first key stage at the schools maintained by the authority (regulation 7 and Schedule 1).

Rhaid i gyrff llywodraethu ysgolion a gynhelir a pherchenogion ysgolion arbennig ac ysgolion annibynnol nas cynhelir sydd â disgyblion 15, 16, 17 neu 18 oed roi gwybodaeth benodedig i Gynulliad Cenedlaethol Cymru am eu canlyniadau (rheoliad 8 ac Atodlen 2).

Rhaid i gyrff llywodraethu ysgolion a gynhelir a pherchenogion ysgolion annibynnol ac ysgolion arbennig nas cynhelir roi gwybodaeth i Gynulliad Cenedlaethol Cymru am absenoldebau sydd wedi'u hawdurdodi a'r rhai heb eu hawdurdodi (rheoliad 9).

Mae Rhan 4 yn ei gwneud yn ofynnol i gyrff llywodraethu ysgolion a gynhelir roi gwybodaeth i'r Asiantaeth Casglu Data Cenedlaethol (corff sy'n cydlynu gwybodaeth am ganlyniadau asesiadau Cwricwlwm Cenedlaethol disgyblion) a'r asiantaeth farcio allanol (corff sy'n marcio ymatebion disgyblion i brofion Cwricwlwm Cenedlaethol) am ddisgyblion unigol sy'n ymwneud â disgyblion sydd ar ddiwedd neu ar drothwy diwedd blwyddyn olaf yr ail neu'r trydydd cyfnod allweddol (rheoliadau 10 ac 11 ac Atodlen 3).

Governing bodies of maintained schools and proprietors of non-maintained special schools and independent schools with pupils aged 15, 16, 17 or 18 must provide the National Assembly for Wales with specified information about their results (regulation 8 and Schedule 2).

Governing bodies of maintained schools and the proprietors of independent and non-maintained special schools must provide the National Assembly for Wales with information about authorised and unauthorised absences (regulation 9).

Part 4 requires governing bodies of maintained schools to provide, respectively, the National Data Collection Agency (a body which collates information about pupils' National Curriculum assessment results) and the external marking agency (a body which marks pupils' responses to National Curriculum tests) with individual pupil information relating to pupils who are eligible for assessment in the second or third key stage (regulations 10 and 11 and Schedule 3).

Mae Cynulliad Cenedlaethol Cymru yn gwneud y Rheoliadau canlynol drwy arfer y pwerau a roddwyd i'r Ysgrifennydd Gwladol gan adrannau 29(3), 408, 537, 537A(1) a (2) a 569(4) a (5) o Ddeddf Addysg 1996(a) ac sydd wedi'u breinio bellach yng Nghynulliad Cenedlaethol Cymru(b) ac ar ôl ymgynghori â'r personau hynny yr oedd ymgynghori â hwy yn ymddangos i'r Cynulliad ei fod yn ddymunol:

The National Assembly for Wales makes the following Regulations in exercise of the powers conferred on the Secretary of State by sections 29(3), 408, 537, 537A(1) and (2) and 569(4) and (5) of the Education Act 1996(a) and now vested in the National Assembly for Wales(b) and after consulting with those persons with whom consultation appeared to the National Assembly for Wales to be desirable pursuant to section 408(5) of the Education Act 1996:

General

1.-(1) Enw'r Rheoliadau hyn yw Rheoliadau Addysg (Gwybodaeth am Berfformiad Ysgolion) (Cymru) 2004 a deuant i rym ar 30 Ebrill 2004.

1.-(1) These Regulations are called the Education (School Performance Information) (Wales) Regulations 2004 and come into force on 30th April 2004.

2.-(1) Yn y rheoliadau hyn, onid yw'r cyd-destun yn mynnu fel arall:

ystyr "absenoldeb heb ei awdurdodi" ("*unauthorised absence*") yw achlysur pan gofnodir disgybl yn absennol heb awdurdod yn unol â Rheoliadau Addysg (Cofrestru Disgyblion) 1995 ac mae "absenoldeb wedi'i awdurdodi" ("*authorised absence*") i'w ddehongli yn unol â hynny;

ystyr "ACCAC" ("*ACCAC*") yw Awdurdod Cymwysterau, Cwricwlwm ac Asesu Cymru (neu the Qualifications, Curriculum and Assessment Authority for Wales)(a);

ystyr "asesiadau statudol" ("*statutory assessments*") yw trefniadau'r asesiadau hynny a bennir gan y Cynulliad mewn gorchymyn a wneir o dan adran 108(3)(c) o Ddeddf 2002 ac mae "lefel" ("*level*") i'w ddehongli yn unol â darpariaethau'r gorchymyn hwnnw;

ystyr "Asiantaeth Casglu Data Cenedlaethol" ("*National Data Collection Agency*") yw corff sydd, at ddibenion neu mewn cysylltiad â swyddogaethau'r Cynulliad sy'n ymwneud ag addysg, yn gyfrifol am gydlynu gwybodaeth sy'n ymwneud â disgyblion;

ystyr "asiantaeth farcio allanol" ("*external marking agency*") yw corff a enwebwyd gan ACCAC ac a gymeradwywyd gan y Cynulliad i farcio profion y Cwricwlwm Cenedlaethol;

ystyr "awdurdod" ("*authority*") yw-

- (i) mewn perthynas ag ysgol a gynhelir gan awdurdod addysg lleol, yr awdurdod hwnnw; a
- (ii) mewn perthynas ag ysgol arbennig neu ysgol annibynnol nas cynhelir, yw'r awdurdod addysg lleol y lleolir yr ysgol yn ei ardal;

ystyr "blwyddyn adrodd yr ysgol" ("*reporting school year*") yw'r flwyddyn ysgol yn union o flaen y flwyddyn ysgol y mae'r wybodaeth a roir i'r Cynulliad i'w gyhoeddi gan y Cynulliad neu, yn ôl y digwydd, yr awdurdodau addysg lleol;

mae i "blwyddyn ysgol" yr ystyr a roddir i "*school year*" gan adran 579(1) o Ddeddf 1996(b);

(2) These Regulations apply only in relation to Wales.

Interpretation

2.-(1) In these Regulations, except where the context otherwise requires-

"the 1996 Act" ("*Deddf 1996*") means the Education Act 1996;

"the 2002 Act" ("*Deddf 2002*") means the Education Act 2002(a);

"ACCAC" ("*ACCAC*") means the Qualifications, Curriculum and Assessment Authority for Wales or Awdurdod Cymwysterau, Cwricwlwm ac Asesu Cymru(b);

"approved external qualification" ("*cymhwyster allanol a gymeradwywyd*") is a qualification within the meaning of section 96(5) of the Learning and Skills Act 2000(c) that was, at the relevant time, approved under section 99 of that Act for the purposes of section 96 of that Act;

"authority" ("*awdurdod*") means-

- (i) in relation to a school maintained by a local education authority that authority; and
- (ii) in relation to a non-maintained special school or an independent school, the local education authority in whose area the school is situated;

"external marking agency" ("*asiantaeth farcio allanol*") means a body nominated by ACCAC and approved by the National Assembly to mark NC tests;

"maintained school" ("*ysgol a gynhelir*") means-

- (i) any community, foundation or voluntary school, or
- (ii) any community or foundation special school which is not established in a hospital,

but excludes any nursery school;

"the National Assembly" ("*Cynulliad Cenedlaethol*") means the National Assembly for Wales;

"National Data Collection Agency" ("*Asiantaeth Casglu Data Cenedlaethol*") means a body which, for the purposes of or in connection with the functions of the National Assembly relating to education, is responsible for collating information relating to pupils;

ystyr "Canllawiau ar yr Asesu Statudol a'r Trefniadau Adrodd" ("*Statutory Assessment and Reporting Arrangements guidance*") yw'r canllawiau a gyhoeddir gan ACCAC bob blwyddyn ysgol ar weinyddiaeth yr asesiadau statudol;

ystyr "Cynulliad Cenedlaethol" ("*National Assembly*") yw Cynulliad Cenedlaethol Cymru;

mae "cymhwyster allanol a gymeradwywyd" ("*approved external qualification*") yn gymhwyster o fewn ystyr adran 96(5) o Ddeddf Dysgu a Medrau 2000(a) a gafodd ei gymeradwyo, ar yr adeg berthnasol, o dan adran 99 o'r Ddeddf honno at ddibenion adran 96 o'r Ddeddf honno;

mae i "diwrnod ysgol" yr ystyr a roddir i "*school day*" gan adran 579(1) o Ddeddf 1996;

ystyr "Ddeddf 1996" ("*the 1996 Act*") yw Deddf Addysg 1996;

ystyr "Ddeddf 2002" ("*the 2002 Act*") yw Deddf Addysg 2002(b);

ystyr "NQF" ("*NQF*") yw Fframwaith Cymwysterau Cenedlaethol sy'n cynnwys cymwysterau achrededig gan ACCAC, yr Awdurdod Cymwysterau a Chwricwlwm a Chyngor Gogledd Iwerddon ar gyfer Arholiadau Cwricwlwm ac Asesiadau ac ystyr "lefel NQF" ("*NQF level*") yw'r lefel(au) yr achredir y cymwysterau o fewn NQF;

ystyr "profion Cwricwlwm Cenedlaethol" a "thasgau Cwricwlwm Cenedlaethol" ("*NC tests and NC tasks*") yn eu trefn, yw profion Cwricwlwm Cenedlaethol a thasgau Cwricwlwm Cenedlaethol a roddir i ddisgyblion yn unol â'r trefniadau statudol;

ystyr "pynciau perthnasol" ("*relevant subjects*") yw-

- (a) o ran asesiad athrawon ac unrhyw gyfnod allweddol, yr holl bynciau hynny y mae'n ofynnol i'r disgybl neu'r disgyblion sy'n eu hastudio gael eu hasesu drwy asesiad athrawon;
- (b) o ran profion Cwricwlwm Cenedlaethol ac unrhyw gyfnod allweddol, yr holl bynciau hynny y mae'n ofynnol i'r disgybl neu'r disgyblion sy'n eu hastudio gael eu hasesu drwy roi'r cyfryw broffion; ac
- (c) o ran tasgau Cwricwlwm Cenedlaethol ac unrhyw gyfnod allweddol, yr holl bynciau hynny y mae'n ofynnol rhoi'r tasgau arnynt i'r disgybl neu'r disgyblion sy'n eu hastudio,

yn y cyfnod allweddol hwnnw yn unol â'r trefniadau statudol;

"NC tests" ("*profion y Cwricwlwm Cenedlaethol*") and "NC tasks" ("*tasgau'r Cwricwlwm Cenedlaethol*") mean, respectively, National Curriculum tests and National Curriculum tasks administered to pupils in accordance with the statutory assessments;

"non-maintained special school" ("*ysgol arbenig nas gynhelir*") means a special school which is not maintained by an authority;

"NQF" ("*NQF*") means the National Qualifications Framework comprising qualifications accredited by ACCAC, the Qualifications and Curriculum Authority and the Northern Ireland Council for the Curriculum Examinations and Assessment and "NQF level" ("*lefel NQF*") means the level(s) to which qualifications are accredited within the NQF;

"relevant subjects" ("*pynciau perthnasol*") means-

- (a) in relation to teacher assessment and any key stage, all those subjects in respect of which the pupil or pupils concerned are required to be assessed by teacher assessment;
- (b) in relation to NC tests and any key stage, all those subjects in respect of which the pupil or pupils concerned are required to be assessed by the administration of such tests; and
- (c) in relation to NC tasks and any key stage, all those subjects in respect of which such tasks are required to be administered to the pupil or pupils concerned,

in that key stage in accordance with the statutory assessments;

"reporting school year" ("*blwyddyn adrodd yr ysgol*") means the school year immediately preceding the school year in which information provided to the National Assembly is to be published by the National Assembly or, as the case may be, local education authorities;

"school day" ("*diwrnod ysgol*") has the meaning given by section 579(1) of the 1996 Act(a);

"school year" ("*blwyddyn ysgol*") has the meaning given by section 579(1) of the 1996 Act;

"special school" ("*ysgol arbennig*") has the meaning given by section 337 of the 1996 Act(b);

"Statutory Assessment and Reporting Arrangements guidance" ("*Canllawiau ar yr Asesu Statudol a'r Trefniadau Adrodd*") means the guidance published by ACCAC each school year on the administration of statutory assessments;

"statutory assessments" ("*asesiadau statudol*")

ystyr "rhif unigryw disgybl" ("*unique pupil number*") yw cyfuniad o rifau sydd ynghyd â llythrennau neu lythrennau yn cael ei ddyrannu i ddisgybl ac sy'n benodol i'r disgybl hwnnw, drwy ddefnyddio fformiwla a benderfynwyd gan y cynulliad Cenedlaethol;

ystyr "ysgol a gynhelir" ("*maintained school*") yw-

- (i) unrhyw ysgol gymunedol, ysgol sefydledig, neu ysgol wirfoddol, neu
- (ii) unrhyw ysgol gymunedol arbennig neu ysgol sefydledig arbennig na chafodd ei sefydlu mewn ysbyty,

ond nid yw'n cynnwys unrhyw ysgol feithrin;

mae i "ysgol arbennig" yr ystyr a roddir i "*special school*" gan adran 337 o Ddeddf 1996 (a); ac

ystyr "ysgol arbennig nas cynhelir" ("*non-maintained special school*") yw ysgol arbennig nas cynhelir gan awdurdod.

(2) Yn y Rheoliadau hyn, onid yw'r cyd-destun yn mynnu fel arall -

- (a) mae cyfeiriadau at ddisgyblion o oedran penodol yn gyfeiriad at ddisgyblion a gyrhaeddodd yr oedran hwnnw yn ystod y cyfnod o ddeuddeg mis a ddaeth i ben ar 31 Awst cyn dechrau blwyddyn adrodd yr ysgol, pan fo blwyddyn adrodd yr ysgol yn cychwyn ar ôl y dyddiad hwnnw, neu'r 31 Awst sy'n dod ym mlwyddyn adrodd yr ysgol, pan fo blwyddyn adrodd yr ysgol yn dechrau ar neu o flaen y dyddiad hwnnw, ac yr oeddent yn ddisgyblion cofrestredig yn yr ysgol ar y trydydd dydd Iau yn Ionawr ym mlwyddyn adrodd yr ysgol;
- (b) mae cyfeiriadau at gymwysterau allanol a gymeradwywyd y rhoddwyd enwau disgyblion yn yr ysgol ar eu cyfer yn cynnwys cymwysterau allanol a gymeradwywyd y rhoddwyd eu henwau ar eu cyfer er nad ydynt yn unol ag adran 402 o Ddeddf 1996(b); ac
- (c) mae cyfeiriadau at gyfnodau allweddol yn gyfeiriadau at y cyfnodau a nodir yn adran 103(1) o Ddeddf 2002.

(3) Pan fydd y Rheoliadau hyn yn ei gwneud yn ofynnol i wybodaeth gael ei throsglwyddo mewn ffurf ddarllenadwy ar beiriant, gellir bodloni'r gofyniad hwnnw drwy drosglwyddo'r wybodaeth-

- (a) drwy wefan ryngwryd ddiogel a ddarparwyd i'r diben hwnnw gan neu ar ran y Cynulliad Cenedlaethol,

means such assessment arrangements as are specified by the National Assembly in an order made under section 108(3)(c) of the 2002 Act and "level" ("*lefel*") is to be construed in accordance with the provisions of such orders;

"unauthorised absence" ("*absenoldeb heb ei awdurdodi*") means an occasion on which a pupil is recorded as absent without authority pursuant to the Education (Pupil Registration) Regulations 1995 and "authorised absence" ("*absenoldeb wedi'i awdurdodi*") is to be construed accordingly; and

"unique pupil number" ("*Rhif unigryw disgybl*") means a combination of numbers which together with a letter or letters is allocated to a pupil and are particular to that pupil, by use of a formula determined by the National Assembly.

(2) In these Regulations, except where the context otherwise requires-

- (a) references to pupils of a particular age are to pupils who attained that age during the period of twelve months ending on the 31st August preceding the commencement of the reporting school year, where the reporting school year begins after that date, or the 31st August which falls within the reporting school year, where the reporting school year begins on or before that date, and who were registered pupils at the school on the third Thursday in January in the reporting school year;
- (b) references to approved external qualifications for which pupils at the school were entered include approved external qualifications for which they were entered otherwise than in pursuance of section 402 of the 1996 Act(a); and
- (c) references to key stages are references to the periods set out in section 103(1) of the 2002 Act.

(3) Where these Regulations require or permit information to be transferred in machine readable form, that requirement may be met by transferring the information-

- (a) through a secure internet website provided for that purpose by or on behalf of the National Assembly,
