EXPLANATORY NOTE

Mae Adran 143(2) o Ddeddf Cyllid Llywodraeth Leol 1988 a pharagraffau 1 a 5 o Atodlen 11 iddi yn rhoi'r pŵer i'r Ysgrifennydd Gwladol wneud rheoliadau mewn perthynas â Thribiwnlysoedd Prasio. I'r graddau y maent yn ymwneud â Chymru, trosglwyddwyd y pwerau hyn i Gynulliad Cenedlaethol Cymru gan Orchymyn Cynulliad Cenedlaethol Cymru (Trosglwyddo Swyddogaethau) 1999. Y prif reoliadau i Gymru, a wnaed o dan y pwerau hyn yw Rheoliadau Tribiwnlysoedd Prasio (Cymru) 1995 ("Rheoliadau 1995") fel y'u diwygiwyd gan Reoliadau Tribiwnlysoedd Prasio (Diwygio) (Cymru) 2001 ("Rheoliadau 2001"). Mae'r Rheoliadau presennol hyn yn gwneud darpariaeth bellach mewn perthynas â Thribiwnlysoedd Prasio yng Nghymru.

Section 143(2) of and paragraphs 1 and 5 of Schedule 11 to the Local Government Finance Act 1988 confer upon the Secretary of State the power to make regulations in relation to Valuation Tribunals. Insofar as they relate to Wales, these powers were transferred to the National Assembly for Wales by the National Assembly for Wales (Transfer of Functions) Order 1999. The principal regulations for Wales, made under these powers are the Valuation Tribunals (Wales) Regulations 1995 ("the 1995 Regulations") as amended by the Valuation Tribunals (Amendment) (Wales) Regulations 2001 ("the 2001 Regulations"). These present Regulations make further provision in respect of Valuation Tribunals in Wales.

Mae Rheoliadau 1995 yn gwneud darpariaethau ynghylch bod yn aelod o Dribiwnlysoedd Prasio yng Nghymru. Mae Rheoliad 4(2)(d) yn darparu y bydd aelod o dribiwnlys yn peidio â dal swydd pan fydd yn cyrraedd 72 oed.

The 1995 Regulations make provisions in relation to the membership of Valuation Tribunals in Wales. Regulation 4(2)(d) provides that a member of a tribunal will cease to hold office once attaining the age of 72 years.

Mae Rheoliad 7(1)(e) o Reoliadau 1995 yn darparu y caiff aelod ei anghymhwysu rhag cael ei benodi neu rhag parhau i fod yn aelod os yw'n 72 oed neu'n hŷn.

Regulation 7(1)(e) of the 1995 Regulations provides that a member shall be disqualified from being appointed or continuing to be a member if aged 72 years or more.

Mae Rheoliad 3 o'r Rheoliadau hyn yn diwygio Rheoliadau 1995 fel bod Rheoliadau 4(2)(d) a 7(1)(e) yn cael eu hepgor. Effaith y diwygiad hwn yw na fydd aelod o Dribiwnlys Prasio yng Nghymru yn peidio â dal swydd neu'n cael ei anghymhwysu rhag cael ei benodi neu rhag parhau i fod yn aelod ar ôl cyrraedd 72 oed.

Regulation 3 of these Regulations amend the 1995 Regulations so that Regulations 4(2)(d) and 7(1)(e) are omitted. The effect of this amendment is that a member of a Valuation Tribunal in Wales will not cease to hold office or be disqualified from being appointed or continuing to be a member once attaining the age of 72 years.

Mae Cynulliad Cenedlaethol Cymru, trwy arfer y pwerau a roddwyd iddo gan adran 143(2) o Ddeddf Cyllid Llywodraeth Leol 1988 a pharagraffau 1 a 5 o Atodlen 11 iddi(a) drwy hyn yn gwneud y Rheoliadau canlynol:

The National Assembly for Wales, in exercise of the powers vested in it under section 143(2) of and paragraphs 1 and 5 of Schedule 11 to the Local Government Finance Act 1988(a) hereby makes the following Regulations:

1. Enw'r Rheoliadau hyn yw Rheoliadau Tribiwnlysoedd Prasio (Cymru) (Diwygio) 2004, maent yn gymwys i Gymru yn unig a deuant i rym ar 31 Mai 2004.

1. These Regulations are called the Valuation Tribunals (Wales) (Amendment) Regulations 2004, they apply to Wales only and come into force on 31st May 2004.

2. Yn y Rheoliadau hyn -

2. In these Regulations -

ystyr "Rheoliadau 1995" ("*the 1995 Regulations*") yw Rheoliadau Tribiwnlysoedd Prasio (Cymru) 1995(b).

"the 1995 Regulations" ("*Rheoliadau 1995*") means the Valuation Tribunals (Wales) Regulations 1995(b).

The functions of the Secretary of State under the above sections and schedule were, so far as exercisable in relation to Wales, transferred to the National Assembly for Wales by article 2 of and Schedule 1 to the National Assembly for Wales (Transfer of Functions) Order 1999, S.I. 1999/672.

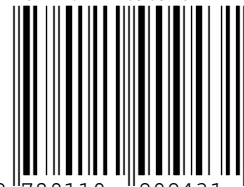
