Mae'r Gorchymyn hwn yn dirymu Gorchymyn Tribiwnlysoedd Prasio Lesddaliadau (Taliadau Gwasanaeth, Yswiriant neu Geisiadau am Benodi Rheolwyr) 1997 ("Gorchymyn 1997") i'r graddau y mae'n effeithiol mewn perthynas â Chymru.

This Order revokes the Leasehold Valuation Tribunals (Service Charges, Insurance or Appointment of Managers Applications) Order 1997 ("the 1997 Order") in so far as it has effect in relation to Wales.

Mae Gorchymyn 1997 yn rhagnodi'r manylion sydd i'w cynnwys mewn -

The 1997 Order prescribes the particulars to be contained in -

- (a) ceisiadau i dribiwnlys o dan -
 - (i) adrannau 19(2A) neu (2B) o Ddeddf Landlord a Thenant 1985;
 - (ii) adran 20C o'r Ddeddf honno;
 - (iii) paragraff 8 o'r Atodlen i'r Ddeddf honno;
 - (iv) adran 22(3) o Ddeddf Landlord a Thenant 1987;
 - (v) adran 24(1) o'r Ddeddf honno; a
 - (vi) adran 24(9) o'r Ddeddf honno;
- (b) ceisiadau i dribiwnlys am ganiatâd i apelio i'r Tribiwnlys Tiroedd.

- (a) applications to a tribunal under -
 - (i) sections 19(2A) or (2B) of the Landlord and Tenant Act 1985;
 - (ii) section 20C of that Act;
 - (iii) paragraph 8 of the Schedule to that Act;
 - (iv) section 22(3) of the Landlord and Tenant Act 1987;
 - (v) section 24(1) of that Act; and
 - (vi) section 24(9) of that Act;
- (b) applications to a tribunal for leave to appeal to the Lands Tribunal.

Mae Gorchymyn 1997 yn parhau i fod yn gymwys i unrhyw gais sy'n cael ei wneud cyn 31 Mawrth 2004.

The 1997 Order continues to apply to any application made before the 31st March 2004.

Mae Rheoliadau Tribiwnlysoedd Prasio Lesddaliadau (Gweithdrefn) (Cymru) 2004 yn gwneud darpariaeth ynglŷn â'r manylion sydd i'w cynnwys gyda cheisiadau penodedig sy'n cael eu cyflwyno i dribiwnlys prasio lesddaliadau ar neu ar ôl 31 Mawrth 2004.

The Leasehold Valuation Tribunals (Procedure) (Wales) Regulations 2004 make provision about the particulars to be included with specified applications made to a leasehold valuation tribunal on or after 31st March 2004.

The National Assembly for Wales, in exercise of the powers conferred upon it by section 31B of the Landlord and Tenant Act 1985(a) and section 24B of the Landlord and Tenant Act 1987(b), hereby makes the following Order:

1. Enw'r Gorchymyn hwn yw Gorchymyn Tribiwnlysoedd Prasio Lesddaliadau (Taliadau Gwasanaeth, Yswiriant neu Geisiadau am Benodi Rheolwyr) (Dirymu ac Arbed) (Cymru) 2004 a daw i rym ar 31 Mawrth 2004.

Name and commencement

1. This Order is called the Leasehold Valuation Tribunals (Service Charges, Insurance or Appointment of Managers Applications) (Revocation and Saving) (Wales) Order 2004 and shall come into force on 31st March 2004.

Dirymu ac arbed

2.-(1) Yn ddarostyngedig i baragraff (2), dirymir drwy hyn Orchymyn Tribiwnlysoedd Prasio Lesddaliadau (Taliadau Gwasanaeth, Yswiriant neu Geisiadau am Benodi Rheolwyr) 1997(c) mewn perthynas â Chymru.

Revocation and saving

2.-(1) Subject to paragraph (2), the Leasehold Valuation Tribunals (Service Charges, Insurance or Appointment of Managers Applications) Order 1997(c) is hereby revoked in relation to Wales.

Trosglwyddwyd swyddogaethau'r Ysgrifennydd Gwladol o dan adran 31B, i'r graddau yr oeddent yn arferadwy mewn perthynas â Chymru, i Gynulliad Cenedlaethol Cymru gan erthygl 2 o Orchymyn Cynulliad Cenedlaethol Cymru (Trosglwyddo Swyddogaethau) 1999 ac Atodlen 1 iddo (O.S. 1999/672) ("Gorchymyn 1999"), y mae diwygiadau iddo nad ydynt yn berthnasol i'r Gorchymyn hwn.
