Mae'r Rheoliadau hyn yn diwygio ymhellach Reoliadau Trwyddedu Diwygio Gwastraff 1994 ("Rheoliadau 1994") mewn perthynas â Chymru.

Mae rheoliad 10 o Reoliadau 1994 yn rhagnodi'r manylion y mae'n rhaid i bob awdurdod rheoli gwastraff eu rhoi ar y gofrestr gyhoeddus y mae'n ei chadw o dan adran 64(1) o Ddeddf Diogelu'r Amgylchedd 1990. Mae rheoliad 3 o'r Rheoliadau hyn yn ychwanegu categori pellach i'r manylion hynny, sef y sgoriau a ddaw allan o unrhyw werthusiad risg ar gyfer safle y mae trwydded rheoli gwastraff yn perthyn iddo.

Mae rheoliad 12 o Reoliadau 1994 yn rhagnodi mathau o offer sydd i'w trin fel offer symudol at ddibenion Rhan II o Ddeddf Diogelu'r Amgylchedd 1990. Mae rheoliad 4 o'r Rheoliadau hyn yn diwygio'r disgrifiad o'r math o offer a ragnodir yn rheoliad 12(1)(d) o Reoliadau 1994 ac yn ychwanegu'r mathau canlynol:

- (a) offer ar gyfer tynnu dŵr o fwd, llaid, priddoedd a charthion;
- (b) offer ar gyfer trin llaid drwy ei sefydlogi â chalch; a
- (c) offer ar gyfer trin deunydd, sylweddau neu gynnyrch halogedig at ddibenion gwaith adferol mewn perthynas â thir neu ddyfroedd rheoledig.

(Amendment) (Wales) Regulations

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations further amend the Waste Management Licensing Regulations 1994 ("the 1994 Regulations") in relation to Wales.

Regulation 10 of the 1994 Regulations prescribes the particulars which each waste regulation authority must enter in the public register which it maintains under section 64(1) of the Environmental Protection Act 1990. Regulation 3 of these Regulations adds to those particulars a further category, namely the scores which result from any risk appraisal for a site to which a waste management licence relates.

Regulation 12 of the 1994 Regulations prescribes descriptions of plant which are to be treated as being mobile plant for the purposes of Part II of the Environmental Protection Act 1990. Regulation 4 of these Regulations amends the description of the plant prescribed in regulation 12(1)(d) of the 1994 Regulations and adds the following descriptions:

- (a) plant for the dewatering of muds, sludges, soils and dredgings;
- (b) plant for the treatment of sludge by lime stabilisation; and
- (c) plant for the treatment of contaminated material, substances or products, for the purpose of remedial action with respect to land or controlled waters.

The Waste Management Licensing (Amendment) (Wales) Regulations 2004

The National Assembly for Wales, in exercise of the powers conferred upon the Secretary of State by sections 29(10) and 64(1) of the Environmental Protection Act 1990(a) and now vested in the National Assembly for Wales(b), hereby makes the following Regulations:

Citation, commencement and application

1.-(1) These Regulations may be cited as the Waste Management Licensing (Amendment) (Wales) Regulations 2004 and come into force on 31 January 2004.

(2) These Regulations apply to Wales.

Amendment of the Waste Management Licensing Regulations 1994

2. The Waste Management Licensing Regulations 1994(c) are amended as follows.

Amendment of regulation 10: public registers

3. In regulation 10 (particulars to be entered in public registers), at the end of paragraph (1)(g) insert:

"(iv) the scores which result from any risk appraisal relating to a site which is the subject of a waste management licence;".

- 4.-(1) In regulation 12 (mobile plant) -
- (a) in paragraph (1) -
 - (i) for sub-paragraph (d), substitute - "(d)plant for the treatment of clinical waste;" ;
 - (ii) after sub-paragraph (e), insert - "(f) plant for the dewatering of muds, sludges, soils and dredgings;
 - (g) plant for the treatment by lime stabilisation of sludge;
 - (h) plant for the treatment of contaminated material, substances or products, for the purpose of remedial action with respect to land or controlled waters;" ; and
 - (b) after paragraph (2), insert -
 - "(3) For the purposes of paragraph (1)(h), "controlled waters" has the meaning given by section 104 of the Water Resources Act 1991(a).".


