Mae'r Rheoliadau hyn yn diwygio Rheoliadau Addysg (Arolygu Ysgolion) (Cymru) 1998 er mwyn newid y cyfnod y mae'n rhaid cwblhau adroddiad arolygu ynddo i 35 diwrnod gwaith ym mhob achos, a'r cyfnod y mae'n rhaid paratoi cynllun gweithredu ynddo i 45 diwrnod gwaith ym mhob achos.

These Regulations amend the Education (School Inspection) (Wales) Regulations 1998 so as to change the period within which an inspection report must be completed to 35 working days in every case, and the period within which an action plan must be prepared to 45 working days in every case.

Mae Cynulliad Cenedlaethol Cymru yn gwneud y Rheoliadau canlynol drwy arfer y pwerau a roddwyd i'r Ysgrifennydd Gwladol gan adrannau 15(2), 17(2)(a), 21(2)(a) a 45(3) o Ddeddf Arolygu Ysgolion 1996(a), a pharagraffau 2(2) a 3(1) o Atodlen 4 iddi, ac sydd bellach wedi'u breinio ynddo(b).

The National Assembly for Wales makes the following Regulations in exercise of the powers conferred on the Secretary of State by sections 15(2), 17(2)(a), 21(2)(a) and 45(3) of, and paragraphs 2(2) and 3(1) of Schedule 4 to the Schools Inspection Act 1996(a), and now vested in it(b).

Enw, cychwyn a chymhwyso

1.-(1) Enw'r Rheoliadau hyn yw Rheoliadau Addysg (Arolygu Ysgolion) (Diwygio) (Cymru) 2004 a deuant i rym ar 1 Medi 2004.

(2) Maent yn gymwys i Gymru yn unig.

Name, commencement, application

1.-(1) These Regulations are called the Education (School Inspection) (Amendment) (Wales) Regulations 2004 and come into force on 1st September 2004.

(2) They apply only in relation to Wales.

Diwygio Rheoliadau Addysg (Arolygu Ysgolion) (Cymru) 1998

2.-(1) Diwygir Rheoliadau Addysg (Arolygu Ysgolion) (Cymru) 1998(c) fel a ganlyn.

(2) Yn rheoliad 7(2) -

- (a) yn lle'r geiriau "five weeks" rhowch y geiriau "35 working days", a
- (b) dilëwch y geiriau ", or, where it is necessary to provide a translation into Welsh or English, the period of seven weeks from that date".

(3) Yn rheoliad 8(1) -

- (a) yn lle'r gair "forty" rhowch y geiriau "forty five", a
- (b) dilëwch y geiriau ", or where it is necessary to provide a translation into Welsh or English, the period of forty five working days from that date".

Amendment of the Education (School Inspection) (Wales) Regulations 1998

2. -(1) The Education (School Inspection) (Wales) Regulations 1998(c) are amended as follows.

(2) In regulation 7(2)-

- (a) for the words "five weeks" substitute the words "35 working days", and
- (b) delete the words ", or, where it is necessary to provide a translation into Welsh or English, the period of seven weeks from that date".

(3) In regulation 8(1)-

- (a) for the word "forty" substitute the words "forty five", and
- (b) delete the words ", or where it is necessary to provide a translation into Welsh or English, the period of forty five working days from that date".

- (5) Yn rheoliad 13(3) -
- (a) yn lle'r gair "forty" rhowch y geiriau "forty five", a
 - (b) dilëwch y geiriau "or within forty five working days from that date where it is necessary to provide a translation into Welsh or English,".

- (4) In regulation 13(2)-
- (a) for the words "five weeks" substitute the words "35 working days", and
 - (b) delete the words "or within seven weeks from that date where it is necessary to provide a translation into Welsh or English,".

- (5) In regulation 13(3)-
- (a) for the word "forty" substitute the words "forty five", and
 - (b) delete the words "or within forty five working days from that date where it is necessary to provide a translation into Welsh or English,".

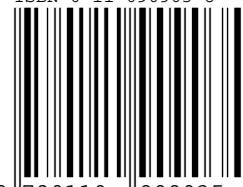
