Mae'r Rheoliadau hyn yn cymhwysyo addasiadau trosiannol i Ddeddf Addysg 2002 mewn cysylltiad â dwyn i rym ddarpariaethau'r Ddeddf drwy Orchymyn Deddf Addysg 2002 (Cychwyn Rhif 7) (Cymru) 2004. Maent yn gwneud diwygiadau hefyd i nifer o reoliadau sy'n ganlyniad yn bennaf i'r gofyniad newydd sydd wedi'i osod ar ysgolion meithrin a gynhelir i gael cyrff llywodraethu.

Mae'r cyfeiriadau isod at adrannau ac Atodlenni (heb fanylion pellach) yn gyfeiriadau at adrannau o Ddeddf Addysg 2002 ac Atodlenni iddi.

Mae Rheoliad 3 yn diwygio adran 28D(7)(a) o Ddeddf Gwahaniaethu ar Sail Anabledd 1995 fel y byddai'n glir, o'i darllen gyda'r diwygiadau i'r Ddeddf honno a wnaed gan baragraffau 26 a 29 o Atodlen 21, bod y dyletswyddau o ran cynlluniau hygyrchedd wedi'u gosod ar gyrrff llywodraethu ysgolion meithrin a gynhelir.

Mae Rheoliad 4 yn diwygio'r diffiniad o "proprietor" yn adran 579 o Ddeddf Addysg 1996 ("Deddf 1996") fel ei fod yn cynnwys cyfeiriad at gyrrff llywodraethu ysgolion meithrin a gynhelir.

Mae Rheoliad 5 yn darparu bod offeryn llywodraethu presennol ysgol i barhau mewn grym hyd nes y bydd offeryn newydd a wnaed o dan reoliadau o dan adran 20 wedi cymryd ei le.

Mae Rheoliad 6 yn darparu bod darpariaethau Deddf Safonau a Fframwaith Ysgolion 1998 ("Deddf 1998")

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations apply transitional modifications to the Education Act 2002 in connection with the bringing into force of provisions of the Act by the Education Act 2002 (Commencement No. 7) (Wales) Order 2004. They also make amendments to a number of regulations which are mainly consequential on the new requirement on maintained nursery schools to have governing bodies.

References below to sections and Schedules (without more) are references to sections of and Schedules to the Education Act 2002.

Regulation 3 amends section 28D(7)(a) of the Disability Discrimination Act 1995 so that when read with the amendments to that Act made by paragraphs 26 and 29 of Schedule 21, it is clear that the duties in relation to accessibility plans are imposed on governing bodies of maintained nursery schools.

Regulation 4 amends the definition of "proprietor" in section 579 of the Education Act 1996 ("the 1996 Act") so that it includes a reference to governing bodies of maintained nursery schools.

Regulation 5 provides that a school's existing instrument of government is to continue in force until it has been replaced by a new instrument made under regulations under section 20.

Regulation 6 provides that the provisions of the School Standards and Framework Act 1998 ("the 1998 Act") continue to apply in relation to a temporary

Mae'n addasu hefyd adran 44 o Ddeddf 1998 a Rheoliadau Addysg (Ysgolion Newydd) (Cymru) 1999 fel na fydd angen i gorff llywodraethu dros dro o'r fath gael ei ailgyfansoddi fel corff llywodraethu parhaol tan y dyddiad y caiff ei hysbysu ohono gan yr AAll. Mae hyn yn osgoi'r angen i gyrrf llywodraethu gael eu cyfansoddi ar gyfer ysgolion newydd o dan Ddeddf 1998, ac wedyn cael eu hailgyfansoddi o dan y trefniadau newydd.

Mae Rheoliad 7 yn darparu na fydd y gofyniad i gorff llywodraethu gael ei gyfansoddi ar gyfer ysgol feithrin a gynhelir yn gymwys tan 31 Mawrth 2006, ond os bydd corff llywodraethu wedi'i gyfansoddi cyn y dyddiad hwnnw, mae i gael holl bwerau a dyletswyddau corff llywodraethu o'r dyddiad y cafodd ei gyfansoddi.

Mae Rheoliad 8 yn gwneud darpariaeth mewn cysylltiad ag ariannu ysgolion meithrin a gynhelir. Mae'r darpariaethau yn Nedd 1998 sy'n ymwneud ag ariannu ysgolion a gynhelir i fod yn gymwys i ysgolion meithrin a gynhelir o ran y blynnyddoedd ariannol sy'n dechrau ar neu ar ôl 1 Ebrill 2006 yn unig.

Mae Rheoliad 9 yn caniatáu i riant-lywodraethwyr cyrff llywodraethu a gyfansoddwyd o dan Ddeddf 1998, yn ogystal â rhiant-lywodraethwyr cyrff llywodraethu a gyfansoddwyd o dan reoliadau a wnaed o dan adran 19, gael eu trin fel rhiant-lywodraethwyr at ddibenion adran 499 o Ddeddf 1996. Mae adran 499 o Ddeddf 1996 yn galluogi rheoliadau i'w gwneud yn ofynnol i bwyllogor addysg awdurdod lleol gynnwys cynrychiolwyr rhiant-lywodraethwyr.

Mae rheoliadau 10 i 15 yn diwygio rheoliadau amrywiol yn y fath fodd ag i ddarparu iddynt fod yn gymwys i ysgolion meithrin a gynhelir. Y rheoliadau diwygiedig yw: Rheoliadau Cynrychiolwyr Rhiant-Lywodraethwyr a Chynrychiolwyr Eglwysig (Cymru) 2001, Rheoliadau Llywodraethu Ysgolion (Cylch Gwaith) (Cymru) 2000, Rheoliadau Newid Amserau Sesiyau Ysgolion (Cymru) 2000, Rheoliadau Addysg (Talu am Gyflenwadau Anghenion Addysgol Arbennig) 1999, Rheoliadau Anghenion Addysgol Arbennig (Darparu Gwybodaeth gan Awdurdodau Lleol) (Cymru) 2002 a Rheoliadau Addysg (Cofrestru Disgyblion) 1995.

Mae Rheoliad 16 yn darparu bod Rheoliadau Addysg (Gwahardd Disgyblion ac Apelau) (Ysgolion a Gynhelir) (Cymru) 2003 yn gymwys i ysgolion meithrin a gynhelir o ran gwaharddiadau ar neu ar ôl 1 Ebrill 2006 yn unig.

Mae Rheoliadau 17 a 18 yn diwygio Rheoliadau Addysg (Datganiadau Cyllideb) (Cymru) 2002 a Rheoliadau Cyllidebau AAll, Cyllidebau Ysgolion a Chyllidebau Ysgolion Unigol (Cymru) 2003 fel eu bod yn gymwys i ysgolion meithrin a gynhelir.

governing body of a new school constituted under section 44 of the 1998 Act before 31 October 2005. It also modifies section 44 of the 1998 Act and the Education (New Schools) (Wales) Regulations 1999 so that such a temporary governing body need not reconstitute as a permanent governing body until the date notified to them by the LEA. This avoids the need for governing bodies to be constituted for new schools under the 1998 Act, and then re-constitute under the new arrangements.

Regulation 7 provides that the requirement for a governing body to be constituted for a maintained nursery schools does not apply until 31 March 2006, but if a governing body is constituted before that date, they are to have all the powers and duties of a governing body from the date on which they are constituted.

Regulation 8 makes provision in connection with the financing of maintained nursery schools. Provisions of the 1998 Act relating to the financing of maintained schools are to apply to maintained nursery schools only in relation to financial years beginning on and after 1 April 2006.

Regulation 9 allows parent governors of governing bodies constituted under the 1998 Act, as well as parent governors of governing bodies constituted under regulations made under section 19, to be treated as parent governors for the purposes of section 499 of the 1996 Act. Section 499 of the 1996 Act enables regulations to require a local authority's education committee to include representatives of parent governors.

Regulations 10 to 15 amend various regulations so as to provide that they apply to maintained nursery schools. The amended regulations are the Parent Governor Representatives and Church Representatives (Wales) Regulations 2001, the School Government (Terms of Reference) (Wales) Regulations 2000, the Changing of School Session Times (Wales) Regulations 2000, the Education (Payment for Special Educational Needs Supplies) Regulations 1999, the Special Educational Needs (Provision of Information by Local Education Authorities) (Wales) Regulations 2002 and the Education (Pupil Registration) Regulations 1995.

Regulation 16 provides that the Education (Pupil Exclusions and Appeals) (Maintained Schools) (Wales) Regulations 2003 apply to maintained nursery schools only in relation to exclusions on or after 1 April 2006.

Regulation 17 and 18 amend the Education (Budget Statements) (Wales) Regulations 2002 and the LEA Budgets, Schools Budget and Individual Schools Budget (Wales) Regulations 2003 so that they apply to maintained nursery schools.

Mae Rheoliad 19 yn diwygio Rheoliadau Cyfrannau Cyllideb Ysgolion (Cymru) 2004 fel eu bod yn gymwys i ysgolion meithrin a gynhelir ar gyfer y blynnyddoedd ariannol sy'n dechrau ar ôl 31 Mawrth 2006 yn unig.

Mae Rheoliad 20 yn diwygio Rheoliadau Fforymâu Ysgolion (Cymru) 2003 fel bod modd i gynrychiolwyr ysgol gynradd ar fforwm ysgol gynnwys cynrychiolydd ysgol feithrin a gynhelir. Mae hyn i adlewyrchu'r ffaith bod ysgolion meithrin a gynhelir i gael cyllidebau dirprwyedig.

Mae Rheoliadau 21 a 22 yn gwneud darpariaeth drosiannol o ran arolygiadau ysgolion o ysgolion meithrin a gynhelir. Mae Rheoliad 23 yn diwygio Rheoliadau Addysg (Arolygu Addysg Feithrin) (Cymru) 1999 o ganlyniad i'r gofyniad i ysgolion meithrin a gynhelir gael cyrff llywodraethu.

Regulation 19 amends the Schools Budget Shares (Wales) Regulations 2004 so that they apply to maintained nursery schools only in respect of financial years beginning after 31 March 2006.

Regulation 20 amends the School Forums (Wales) Regulations 2003 so that representatives of a primary school on a school forum can include a representative of a maintained nursery school. This is to reflect the fact that maintained nursery schools are to have delegated budgets.

Regulations 21 and 22 make transitional provision in relation to school inspections of maintained nursery schools. Regulation 23 amends the Education (Inspection of Nursery Education) (Wales) Regulations 1999 consequential on the requirement for maintained nursery schools to have governing bodies.

The National Assembly for Wales makes the following Regulations in exercise of the powers conferred on it by section 214 of the Education Act 2002(1).

Title, commencement and application

1.-(1) The title of these Regulations is the Education Act 2002 (Transitional Provisions and Consequential Amendments) (Wales) Regulations 2005 and they come into force on 31 October 2005.

(2) These Regulations apply in relation to Wales.

Interpretation

2.-(1) In these Regulations-

"the 1996 Act" ("Deddf 1996") means the Education Act 1996(2);

"the 1998 Act" ("Deddf 1998") means the School Standards and Framework Act 1998(3); and

"the 2002 Act" ("Deddf 2002") means the Education Act 2002.

Modification of section 28D(7) the Disability Discrimination Act 1995

3. In section 28D(7)(a) of the Disability Discrimination Act 1995(4) (Accessibility strategies and plans), after the words "maintained schools" insert the words "and maintained nursery schools".

4. Yn adran 579(1) o Ddeddf 1996(1) (Dehongli cyffredinol), yn y diffiniad o "proprietor", ar ôl "foundation special school" mewnosoder "or a maintained nursery school,".

6.-(1) Er gwaethaf y ffaith bod adran 34 o Ddeddf 2002 wedi dod i rym a bod adran 44 o Ddeddf 1998(4) wedi'i diddymu, mae adran 44 o Ddeddf 1998 a Rheoliadau Addysg (Ysgolion Newydd) (Cymru) 1999(5) i barhau i fod yn gymwys o ran corff llywodraethu dros dro a gyfansoddwyd cyn 31 Hydref 2005.

(2) Pan fo paragraff (1) yn gymwys-

- (a) mae'r darpariaethau yn Nedd 1998 y cyfeirir atynt yn adran 44 o Ddeddf 1998 ac yn Rheoliadau Addysg (Ysgolion Newydd) (Cymru) 1999 ac sydd wedi'u dirymu gan Ddeddf 2002 i gael effaith fel petaent heb eu dirymu;

Modification of section 579(1) of the 1996 Act

4. In section 579(1) of the 1996 Act(1) (General interpretation), in the definition of "proprietor" after "foundation special school" there is inserted "or a maintained nursery school,".

Instruments of government

5. Despite the coming into force of section 20(1) of the 2002 Act and the repeal of section 37(1) of and Schedule 12 to the 1998 Act(2), all instruments of government of maintained schools are to remain in force until replaced by a new instrument of government made in accordance with the Government of Maintained Schools (Wales) Regulations 2005(3).

New schools

6.-(1) Despite the coming into force of section 34 of the 2002 Act and the repeal of section 44 of the 1998 Act(4), section 44 of the 1998 Act and the Education (New Schools) (Wales) Regulations 1999(5) are to continue to apply in relation to a temporary governing body constituted before 31 October 2005.

(2) Where paragraph (1) applies-

- (a) provisions of the 1998 Act referred to in section 44 of the 1998 Act and in the Education (New Schools) (Wales) Regulations 1999 which have been revoked by the 2002 Act are to have effect as though they had not been revoked;
- (b) section 44 of the 1998 Act is to have effect as though subsection (3)(b) were omitted and as though in subsection (4) there were substituted for "the school opening date" the words "the date notified to the temporary governing body by the local education authority"; and
- (c) the Education (New Schools) (Wales) Regulations 1999 are to have effect as though for "the school opening date" in regulation 31(1) there were substituted the words "the date notified to the temporary governing body by the local education authority" and as though regulation 31(3) were omitted.

Ysgolion meithrin a gynhelir

7.-(1) Er gwaethaf y ffaith bod y diffiniad o "maintained school" yn adran 39 o Ddeddf 2002(1) wedi dod i rym, nid oes angen i'r gofynion a osodir gan adrannau 19(1) ac 20(1) o Ddeddf 2002(2) i'r graddau y maent yn ymwnud ag ysgolion meithrin a gynhelir gael eu bodloni tan 31 Mawrth 2006.

(2) Hyd nes y bydd offeryn llywodraethu mewn grym ar gyfer ysgol feithrin a gynhelir o dan adran 20(1) o Ddeddf 2002, dim ond er mwyn galluogi'r offeryn llywodraethu i gael ei wneud a galluogi'r corff llywodraethu i gael ei gyfansoddi ar gyfer yr ysgol honno y mae'r darpariaethau perthnasol yn cael effaith.

(3) Gan hynny, mae Cynulliad Cenedlaethol Cymru, awdurdodau addysg lleol, cyrff llywodraethu a phenaethiaid i barhau i gael yr un swyddogaethau hynny tan yr amser hwnnw, o ran ysgolion meithrin a gynhelir ag yr oedd ganddynt yn union cyn cychwyn y darpariaethau perthnasol.

(4) Yn y rheoliad hwn ystyr "y darpariaethau perthnasol" yw'r darpariaethau yn Nedd Addysg 2002 a gafodd eu dwyn i rym gan Orchymyn Deddf Addysg 2002 (Cychwyn Rhif 7) 2005(3) a darpariaethau'r Rheoliadau hyn, i'r graddau y mae swyddogaethau yn cael eu rhoi i Gynulliad Cenedlaethol Cymru, awdurdodau addysg lleol, cyrff llywodraethu neu benaethiaid gan neu o dan y darpariaethau hynny o ran ysgolion meithrin a gynhelir.

Ysgolion meithrin a gynhelir a chyllidebau dirprwyedig

8. Mae cymhwysyo Pennod 4 o Ran 2 o Ddeddf 1998 i ysgolion meithrin a gynhelir, a hwnnw'n gymhwysyo a wnaed drwy beri i adran 45 o Ddeddf 1998 gael ei diwygio gan baragraff 99(2) o Atodlen 21 i Ddeddf 2002(4), i gael effaith yn y cyfnod sy'n dod i ben yn union cyn 1 Ebrill 2006 ddim ond at ddibenion ariannu ysgolion meithrin a gynhelir mewn unrhyw flwyddyn ariannol sy'n dechrau ar neu ar ôl y dyddiad hwnnw.

Aelodaeth o bwyllgorau addysg

9. Er gwaethaf yr amnewidiad o adran 499(9)(b) o Ddeddf 1996 a wnaed gan baragraff 50 o Atodlen 21 i Ddeddf 2002(5), mae rhiant-lywodraethwr a benodwyd neu a etholwyd i gorff llywodraethu a gyfansodwyd o dan adran 36 o Ddeddf 1998 i'w drin fel rhiant-lywodraethwr hefyd at ddibenion adran 499(6) ac (8) o Ddeddf 1996.

Maintained nursery schools

7.-(1) Despite the coming into force of the definition of maintained school in section 39 of the 2002 Act(1), the requirements imposed by sections 19(1) and 20(1) of the 2002 Act(2) in so far as they relate to maintained nursery schools need not be met until 31 March 2006.

(2) Until an instrument of government is in force for a maintained nursery school under section 20(1) of the 2002 Act, the relevant provisions have effect only for the purpose of enabling the instrument of government to be made and the governing body to be constituted for that school.

(3) Accordingly until such time, the National Assembly for Wales, local education authorities, governing bodies and head teachers are to continue to have those same functions in relation to maintained nursery schools as they had immediately before the commencement of the relevant provisions.

(4) In this regulation "the relevant provisions" means the provisions of the Education Act 2002 brought into force by the Education Act 2002 (Commencement No. 7) Order 2005(3) and the provisions of these Regulations, in so far as functions are conferred on the National Assembly for Wales, local education authorities, governing bodies or head teachers by or under those provisions in relation to maintained nursery schools.

Maintained nursery schools and delegated budgets

8. The application of Chapter 4 of Part 2 of the 1998 Act to maintained nursery schools, made by the amendment of section 45 of the 1998 Act by paragraph 99(2) of Schedule 21 to the 2002 Act(4), is to have effect in the period ending immediately before 1 April 2006 only for the purpose of financing maintained nursery schools in any financial year beginning on and after that date.

Membership of education committees

9.
