Mae'r Rheoliadau hyn yn diwygio Rheoliadau Addysg (Gwybodaeth am Ddisgyblion Unigol) (Cymru) 2003, sy'n ei gwneud yn ofynnol i gyrrff llywodraethu ysgolion a gynhelir ddarparu gwybodaeth ragnodedig am y disgyblion sydd yn yr ysgol i'r awdurdod addysg lleol sy'n cynnal yr ysgol, a hynny ar gais ysgrifenedig yr awdurdod.

Mae rheoliad 2 yn diwygio Rheoliadau 2003 drwy:

- ei gwneud yn ofynnol i gorff llywodraethu ysgol a gynhelir ddarparu gwybodaeth am ddisgyblion unigol i'r awdurdod addysg lleol sy'n ei chynnal, a hynny ar ffurf y gall peiriant ei phrosesu; ac
- ymestyn rhychwant yr wybodaeth y caiff awdurdodau addysg lleol ofyn amdani am ddisgyblion y chweched dosbarth.

The Education (Information About Individual Pupils) (Wales) (Amendment) Regulations 2005

EXPLANATORY NOTE

(*This note is not part of the Regulations*)

These Regulations amend the Education (Information About Individual Pupils) (Wales) Regulations 2003 which require governing bodies of maintained schools to provide the local education authority which maintains the school with prescribed information on pupils at the school on written request from the authority.

Regulation 2 amends the 2003 Regulations by:

- requiring that the governing body of a maintained school provides individual pupil information to the maintaining local education authority in machine readable format; and
- extending the range of information that local education authorities may request on sixth form pupils.

Diwygio Rheoliadau

2.-(1) Diwygir Rheoliadau Addysg (Gwybodaeth am Ddisgyblion Unigol) (Cymru) 2003(3) fel a ganlyn.

(2) Ar ddiwedd rheoliad 3, ychwanegwr y geiriau ", a hynny ar ffurf y gall peiriant ei phrosesu".

(3) Yn Rhan 2 o'r Atodlen-

(a) dileer y gair "a" ar ddiwedd paragraff 1(a);

(b) yn lle paragraff 1(b), rhodder-

The Education (Information About Individual Pupils) (Wales) (Amendment) Regulations 2005

*Made**11 January 2005**Coming into force**18 January 2005*

The National Assembly for Wales makes the following Regulations in exercise of the powers conferred on the Secretary of State by sections 537A(1) and (2) and 569(4) and (5) of the Education Act 1996(1) and now vested in the National Assembly for Wales(2):

Name, commencement and application

1.-(1) These Regulations are called the Education (Information About Individual Pupils) (Wales) (Amendment) Regulations 2005 and come into force on 18 January 2005.

(2) These Regulations apply in relation to Wales.

Amendment of Regulations

2.-(1) The Education (Information About Individual Pupils) (Wales) Regulations 2003(3) are amended as follows.

(2) In regulation 3 add the words "in machine readable format" after the words "must provide to the authority".

(3) In Part 2 of the Schedule -

(a) delete the word "and" at the end of paragraph 1(a);

(b) replace paragraph 1(b) with -

"(b)the title of each learning activity the pupil is studying; and

- (c) pa un a gafodd y disgybl ei sgrinio i ganfod unrhyw anghenion o ran sgiliau sylfaenol llythrenedd a rhifedd ar ddechrau ei raglen o weithgareddau dysgu yn y chweched dosbarth ac, os felly, pa un a oedd ei sgiliau sylfaenol mewn perthynas â llythrenedd a rhifedd-
- (i) heb eu hasesu oherwydd ni chanfyddwyd unrhyw anghenion sgiliau sylfaenol wrth i'r disgybl gael ei sgrinio; neu
 - (ii) wedi'u hasesu, a nodwyd bod sgiliau sylfaenol y disgybl-
 - (aa) yn is na'r lefel mynediad,
 - (bb) ar lefel mynediad 1,
 - (cc) ar lefel mynediad 2,
 - (chch) ar lefel mynediad 3,
 - (dd) ar lefel 1, neu
 - (dddd) yn uwch na lefel 1; neu
 - (iii) yn anhysbys neu gwrrhododd y disgybl i gael ei asesu.";
- (c) ym mharagraff 2, ar ôl y geiriau "Mewn perthynas â", yn lle'r geiriau "cwrs neu weithgaredd dysgu arall", rhodder "gweithgaredd dysgu";
- (ch) dileer y gair "ac" ar ddiwedd paragraff 2(d); a
- (d) ar ôl paragraff 2(dd), rhodder y paragraff a ganlyn-
- "(e) pa un a yw'r disgybl yn parhau i astudio neu a yw wedi cwblhau neu wedi tynnu yn ôl o'r gweithgaredd dysgu; ac
 - (f) os cwblhaodd neu os tynnodd y disgybl yn ôl o'r gweithgaredd dysgu, y dyddiad y cwblhaodd neu y tynnodd y disgybl yn ôl o'r gweithgaredd dysgu, a pha un a yw'r disgybl wedi dechrau astudio gweithgaredd dysgu newydd. "
- (c) whether the pupil was screened to identify any basic skills needs for literacy and numeracy at the beginning of their programme of learning activities in the sixth form and, if so, whether their basic skills in relation to each of literacy and numeracy were -
- (i) not assessed because no basic skills needs were identified when the pupil was screened; or
 - (ii) assessed and their basic skills were identified as being -
 - (aa) below entry level,
 - (bb) entry level 1,
 - (cc) entry level 2,
 - (dd) entry level 3,
 - (ee) level 1, or
 - (ff) above level 1; or
 - (iii) not known or the pupil refused to be assessed.";
- (c) in paragraph 2 delete the words "course or other" after the words "In relation to";
- (d) delete the word "and" at the end of paragraph 2(e); and
- (e) after paragraph 2(f) insert the following -
- "(g) whether the pupil is continuing to study or has completed or withdrawn from the learning activity; and
- (h) where the pupil has completed or withdrawn from the learning activity, the date upon which the pupil completed or withdrew from the learning activity and whether the pupil has begun to study a new learning activity.".
