Mae'r Rheoliadau hyn yn diwygio ymhellach Reoliadau'r Gwasanaeth Iechyd Gwladol (Ffioedd am Gyffuriau a Chyfarpar) (Cymru) 2001 ("y prif Reoliadau") sy'n darparu ar gyfer codi a chasglu ffioedd am gyffuriau a chyfarpar sy'n cael eu cyflenwi gan feddygon a fferyllwyr sy'n darparu gwasanaethau fferyllol a gweinyddol, a chan Fyrddau Iechyd Lleol ac Ymddiriedolaethau GIG i gleifion allanol.

These Regulations further amend the National Health Service (Charges for Drugs and Appliances) (Wales) Regulations 2001 ("the principal Regulations") which provide for the making and recovery of charges for drugs and appliances supplied by doctors and chemists providing pharmaceutical and dispensing services, and by Local Health Boards and NHS Trusts to out-patients.

Mae rheoliad 2 a'r Atodlen yn gostwng y ffi am eitemau ar bresgripsiwn a gyflenwir i gleifion allanol o £5.00 i £4.00. Gostyngir y tâl am hosanau elastig o £5.00 i £4.00 (o £10.00 i £8.00 y pâr) a'r tâl am deits o £10.00 i £8.00. Gostyngir y symiau a ragnodir ar gyfer rhoi tystysgrifau rhagdal o £26.16 i £20.93 am dystysgrif pedwar mis ac o £71.83 i £57.46 am dystysgrif deuddeng mis.

Regulation 2 and the Schedule reduce the charge for items on prescription supplied to out-patients from £5.00 to £4.00. The charge for elastic stockings is reduced from £5.00 to £4.00 (from £10.00 to £8.00 per pair) and that for tights from £10.00 to £8.00. The sums prescribed for the grant of pre-payment certificates are reduced from £26.16 to £20.93 for a four month certificate and from £71.83 to £57.46 for a twelve month certificate.

Mae diwygiadau a wneir gan reoliad 3 yn darparu na fydd ffi yn daladwy gan bersonau o dan 25 oed, neu gan y rhai sy'n 60 oed neu'n hyn, am gyflenwi cyfarpar a chyffuriau'n unol â rheoliad 5 o'r prif Reoliadau (cyflenwi cyffuriau a chyfarpar gan Fyrddau Iechyd Lleol ac Ymddiriedolaethau GIG).

Amendments made by regulation 3 provide that no charge will be payable by persons under the age of 25 years, or those of 60 years or over for the supply of appliances and drugs in accordance with regulation 5 of the principal Regulations (supply of drugs and appliances by Local Health Boards and NHS Trusts).

Mae Cynulliad Cenedlaethol Cymru, drwy arfer y pwerau a roddwyd gan adrannau 77 a 126(4) o Ddeddf y Gwasanaeth Iechyd Gwladol 1977(1) drwy hyn yn gwneud y Rheoliadau canlynol:

The National Assembly for Wales, in exercise of the powers conferred by sections 77 and 126(4) of the National Health Service Act 1977(1) hereby makes the following Regulations:

**Enwi, cychwyn, dehongli a chymhwyso****Citation, commencement, interpretation and application**

1.-(1) Enw'r Rheoliadau hyn yw Rheoliadau'r Gwasanaeth Iechyd Gwladol (Ffioedd am Gyffuriau a Chyfarpar) (Cymru) (Diwygio) 2005 a deuant i rym ar 1 Ebrill 2005.

1.-(1) These Regulations may be cited as the National Health Service (Charges for Drugs and Appliances) (Wales) (Amendment) Regulations 2005 and come into force on 1 April 2005.

(2) Yn y Rheoliadau hyn, ystyr "y prif Rheoliadau" (*the principal Regulations*) yw Rheoliadau'r Gwasanaeth Iechyd Gwladol (Ffioedd am Gyffuriau a Chyfarpar) (Cymru) 2001(2).

(2) In these Regulations "the principal Regulations" (*the principal Regulations*) means the National Health Service (Charges for Drugs and Appliances) (Wales) Regulations 2001(2).

(3) Mae'r Rheoliadau hyn yn gymwys o ran Cymru'n unig.

(3) These Regulations apply in relation to Wales only.

3. Yn rheoliad 8(2)(a), yn lle "paragraff (1)(d)" rhodder "yn unrhyw is-baragraff o blith is-baragraffau (a), (b) neu (d) o baragraff (1)".

### **Amendment of regulation 8 of the principal Regulations**

3. In regulation 8(2)(a), for "paragraph (1)(e)" substitute "in any of sub-paragraphs (a), (b) or (e) of paragraph (1)".
