Mae'r Rheoliadau hyn yn diwygio Rheoliadau Cyngor Addysgu Cyffredinol Cymru (Swyddogaethau) 2000 ("Rheoliadau 2000") mewn perthynas â materion penodol sydd i'w cofnodi ar y gofrestr a gedwir gan Gyngor Addysgu Cyffredinol Cymru ("y Cyngor"). Mae'r gofrestr i ddangos y dyddiad y cyflogwyd person am y tro cyntaf fel athro cyflenwi neu athrawes gyflenwi yn unol â darpariaethau Rheoliadau Addysg (Trefniadau Ymsefydlu ar gyfer Athrawon Ysgol) (Cymru) 2003, fel y'u diwygiwyd gan Reoliadau Addysg (Trefniadau Ymsefydlu ar gyfer Athrawon Ysgol) (Diwygio) (Cymru) 2004 ("y Rheoliadau Ymsefydlu"). Bydd hyn yn galluogi'r Cyngor i ffonitro a ganiateir i berson barhau dan gyflogaeth fel athro cyflenwi neu athrawes gyflenwi o dan y Rheoliadau Ymsefydlu. Mae'r Rheoliadau Ymsefydlu yn gosod terfynau ar y cyfnodau pan geir cyflogi person, sydd heb wasanaethu cyfnod ymsefydlu, yn athro cyflenwi neu'n athrawes gyflenwi.

Mae'r Rheoliadau hyn hefyd yn diwygio Atodlenni 1 a 2 i Reoliadau 2000 fel nad oes angen mwyach i'r Cyngor gofnodi ar y gofrestr y dyddiad pryd y dechreuodd cwrs hyfforddi cychwynnol athrawon ar gyfer athro neu athrawes a phryd y cwblhawyd y cwrs.

The General Teaching Council for Wales (Functions) (Amendment) Regulations 2005

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations amend the General Teaching Council for Wales (Functions) Regulations 2000 ("the 2000 Regulations") in relation to certain of the matters to be recorded on the register kept by the General Teaching Council for Wales ("the Council"). The register is to indicate the date on which a person was first employed as a supply teacher in accordance with the provisions of the Education (Induction Arrangements for School Teachers) (Wales) Regulations 2003, as amended by the Education (Induction Arrangements for School Teachers) (Amendment) (Wales) Regulations 2004 ("the Induction Regulations"). This will enable the Council to monitor whether a person is permitted to continue in employment as a supply teacher under the Induction Regulations. The Induction Regulations impose limits on the periods during which a person who has not served an induction period may be employed as a supply teacher.

These Regulations also amend Schedules 1 and 2 to the 2000 Regulations so that the Council is no longer required to record on the register the date on which a teacher's initial teacher training course started and was completed.

Diwygio Rheoliadau Cyngor Addysgu Cyffredinol Cymru (Swyddogaethau) 2000

2. Diwygir Rheoliadau Cyngor Addysgu Cyffredinol Cymru (Swyddogaethau) 2000(3) fel a ganlyn.

3. Yn Atodlen 1-

(a) yn lle paragraff 13 rhodder y canlynol -

"**13.** Os yw'n hysbys,

(a) y dyddiad pan ddechreuodd yr athro neu'r athrawes yn ei swydd gyntaf yn athro neu athrawes gymwysedig;

Diwygir adran 4 yn rhagolygol gan baragraff 4(2) o Atodlen 12 i Ddeddf Addysg 2002 (p.32), a diwygiwyd hi gan baragraff 77 o Atodlen 21 i'r Ddeddf honno. I gael ystyr "prescribed" a "regulations" gwele adran 43(1).

The General Teaching Council for Wales (Functions) (Amendment) Regulations 2005

*Made**18 January 2005**Coming into force**21 January 2005*

In the exercise of the powers conferred on the Secretary of State by sections 4(1), (2) and (3) and 42(6) and (7) of the Teaching and Higher Education Act 1998(1) and now vested in the National Assembly for Wales(2), and having consulted the General Teaching Council for Wales in accordance with section 42(9) of that Act, the National Assembly for Wales makes the following Regulations:

Name and commencement

1. These Regulations are called the General Teaching Council for Wales (Functions) (Amendment) Regulations 2005 and come into force on 21 January 2005.

Amendment of the General Teaching Council for Wales (Functions) Regulations 2000

2. The General Teaching Council for Wales (Functions) Regulations 2000(3) are amended as follows.

3. In Schedule 1 -

(a) substitute for paragraph 13 the following -

"**13.** If known,

(a) the date on which the teacher took up his or her first post as a qualified teacher;

(b) the date on which the teacher was first employed (if at all) as a supply teacher

- (b) y dyddiad pryd y cyflogwyd yr athro neu'r athrawes am y tro cyntaf (os o gwbl) fel athro cyflenwi neu athrawes gyflenwi o dan baragraff 4 o Atodlen 1 i Reoliadau Addysg (Trefniadau Ymsefydlu ar gyfer Athrawon Ysgol) (Cymru) 2003; a

(b) omit paragraph 14(e) and the preceding "and".

4. In Schedule 2 -

(a) substitute for paragraph 5 the following -

"5. If known,

- (a) the date on which the teacher took up his or her first post as a qualified teacher;
- (b) the date on which the teacher was first employed (if at all) as a supply teacher under paragraph 4 of Schedule 1 to the Education (Induction Arrangements for School Teachers) (Wales) Regulations 2003; and
- (c) the date on which the teacher was first employed (if at all) as a supply teacher by virtue of regulation 18(2) of the Education (Induction Arrangements for School Teachers) (Wales) Regulations 2003.;" and

(b) omit paragraph 6(e) and the preceding "and".
