**Title and application**

1.-(1) The title of this Order is the Animal Welfare Act 2006 (Commencement No.1) (Wales) Order 2007.

(2) This Order applies in relation to Wales.

**Commencement of provisions**

2.-(1) The following provisions of the Animal Welfare Act 2006 come into force when this Order is made-

- (a) Sections 1 to 7;
- (b) Section 8(1), (2), (7) and (8);
- (c) Sections 9 to 12;
- (d) Section 13 and Schedule 1;
- (e) Sections 17 to 45;
- (f) Sections 51 and 52;
- (g) Section 53 and Schedule 2;
- (h) Sections 54 to 60;
- (i) Sections 62 and 63;
- (j) Section 64 to the extent that it relates to the provisions of Schedule 3 specified in paragraph (l);
- (k) Section 65 to the extent that it relates to the provisions of Schedule 4 specified in paragraph (m);
