The 2005 Order is also amended by substituting for reference to the European Communities (Recognition of Professional Qualifications) (First General System) Regulations 2005 reference to the European Communities (Recognition of Professional Qualifications) Regulations 2007.

Mae Gweinidogion Cymru drwy arfer y pwerau a roddwyd i'r Ysgrifennydd Gwladol gan adrannau 7(1) and (3) and 42(6) and (7) o Ddeddf Addysgu ac Addysg Uwch 1998 ac a freiniwyd bellach ynddynt(1), a hwythau o'r farn y caiff Cyngor Addysgu Cyffredinol Cymru, ar y cyd â'i swyddogaethau eraill, gyflawni'n briodol y swyddogaethau ychwanegol a roddir drwy hyn, ac ar ôl ymgynghori fel yr ymddengys iddynt sydd yn briodol yn unol ag adran 7(2) o Ddeddf Addysgu ac Addysg Uwch 1998, yn gwneud y Gorchymyn a ganlyn.

Enwi a chyhwyn

1. Enw'r Gorchymyn hwn yw Gorchymyn Cyngor Addysgu Cyffredinol Cymru (Swyddogaethau Ychwanegol) 2007 a daw i rym ar 20 Hydref 2007.

2. Diwygir Gorchymyn Cyngor Addysgu Cyffredinol Cymru (Swyddogaethau Ychwanegol) 2005(2) fel a ganlyn.

3.-(1) Yn erthygl 2 yn y diffiniad o "y Gyfarwyddeb" ("the Directive") rhodder yn lle'r geiriau "89/48/EEC" y geiriau "2005/36/EC".

The Welsh Ministers in exercise of the powers conferred on the Secretary of State by sections 7(1) and (3) and 42(6) and (7) of the Teaching and Higher Education Act 1998 and now vested in them(1), being of the opinion that the General Teaching Council for Wales may, in conjunction with its other functions, appropriately discharge the additional functions hereby conferred, and having carried out such consultation as appears to them to be appropriate in accordance with section 7(2) of the Teaching and Higher Education Act 1998 make the following Order.

Title and commencement

1. The title of this Order is the General Teaching Council for Wales (Additional Functions) (Amendment) Order 2007 and comes into force on 20 October 2007.

2. The General Teaching Council for Wales (Additional Functions) Order 2005(2) is amended as follows.

3.-(1) In article 2 in the definition of "the Directive" ("y Gyfarwyddeb") for "89/48/EEC" substitute "2005/36/EC".
