Mae'r Rheoliadau hyn yn gwneud diwygiadau pellach i Reoliadau Bwydydd Anifeiliaid (Cymru) 2006 (OS 2006/116 (Cy.14) fel y'u diwygiwyd eisoes gan OS 2006/617 (Cy.69), OS 2006/2928 (Cy.263) ac OS 2006/3256 (Cy.296) ("y Rheoliadau Bwydydd Anifeiliaid").

These Regulations make further amendments to the Feeding Stuffs (Wales) Regulations 2006 (SI 2006/116 (W.14) as already amended by SI 2006/617 (W.69), SI 2006/2928 (W.263) and SI 2006/3256 (W.296) ("the Feeding Stuffs Regulations").

Mae'r Rheoliadau hyn yn darparu ar gyfer gweithredu Cyfarwyddeb y Comisiwn 2006/77/EC sy'n diwygio Atodiad I i Gyfarwyddeb 2002/32/EC Senedd Ewrop a'r Cyngor o ran cyfansoddiad organoclorin mewn bwyd anifeiliaid (OJ Rhif L271, 30.9.2006, t.53).

These Regulations provide for the implementation of Commission Directive 2006/77/EC amending Annex I to Directive 2002/32/EC of the European Parliament and of the Council as regards organochlorine compounds in animal feed (OJ No. L271, 30.9.2006, p.53).

Mae'r Rheoliadau yn diwygio Pennod D o Atodlen 5 i'r Rheoliadau Bwydydd Anifeiliaid, yn bennaf drwy -

The Regulations amend Chapter D of Schedule 5 to the Feeding Stuffs Regulations, principally by -

- (a) pennu terfynau newydd mewn perthynas ag aldrin a dieldrin;
- (b) pennu terfynau newydd mewn perthynas ag endosylffan mewn olew llysiau crai; ac
- (c) rhoi yn lle'r term "fats" y term "fats and oils", (*rheoliad 2(3) ac Atodlen 1*).

- (a) setting new limits in relation to aldrin and dieldrin;
- (b) setting new limits in relation to endosulphan in crude vegetable oil; and
- (c) replacing the term "fats" by the term "fats and oils", (*regulation 2(3) and Schedule 1*).

Mae'r Rheoliadau hefyd yn cywiro gwall hepgor yn Atodlen 6 a gwallau teipograffyddol yn Atodlenni 3 a 7 i Reoliadau Bwydydd Anifeiliaid (*rheoliad 2(2)*, (*4*) a (*5*)).

The Regulations also correct an omission in Schedule 6 and typographical errors in Schedules 3 and 7 to the Feeding Stuffs Regulations (*regulation 2(2)*, (*4*) and (*5*)).

Mae Gweinidogion Cymru yn gwneud y Rheoliadau canlynol drwy arfer y pwerau a roddwyd gan adrannau 66(1), 68(1), 74(A) ac 84 o Ddeddf Amaethyddiaeth 1970(1).

Bu ymgynghori yn ystod gwaith paratoi'r Rheoliadau hyn yn unol â gofynion adran 84(1) o Ddeddf Amaethyddiaeth 1970 neu, fel y bo'n briodol, o Erthygl 9 o Reoliad (EC) Rhif 178/2002 Senedd Ewrop a'r Cyngor(2) sy'n gosod egwyddorion a gofynion cyffredinol cyfraith bwyd, yn sefydlu Awdurdod Diogelwch Bwyd Ewrop ac yn gosod gweithdrefnau o ran materion diogelwch bwyd.

1.-(1) Enw'r Rheoliadau hyn yw Rheoliadau Bwyd Anifeiliaid (Sylweddau Anymunol Penodedig) (Cymru) 2007, a deuant i rym ar 30 Tachwedd 2007.

(2) Mae'r Rheoliadau hyn yn gymwys o ran Cymru.

(1) 1970 p.40. Mae adran 66(1) yn cynnwys y diffiniadau o'r ymadroddion "the Ministers", "prescribed" a "regulations". Trosglwyddwyd swyddogaethau'r Gweinidogion a'r Ysgrifennydd Gwladol, i'r graddau yr oeddent yn arferadwy o ran Cymru, i Gynulliad Cenedlaethol Cymru gan OS 1999/672 ac i Weinidogion Cymru yn rhinwedd adran 162 o Ddeddf Llywodraeth Cymru 2006 (p.32) a pharagraff 30 o Atodlen 11 iddi. Assembly for Wales 8 November 2007
Coming into Force 30 November 2007

The Welsh Ministers make the following Regulations in exercise of the powers conferred by sections 66(1), 68(1), 74A and 84 of the Agriculture Act 1970(1).

There has been consultation during the preparation of these Regulations in accordance with the requirements of section 84(1) of the Agriculture Act 1970 or as appropriate of Article 9 of Regulation (EC) No. 178/2002 of the European Parliament and of the Council(2) laying down the general principles and requirements of food law, establishing the European Food Safety Authority and laying down procedures in matters of food safety.

Title, commencement and application

1.-(1) The title of these Regulations is the Feed (Specified Undesirable Substances) (Wales) Regulations 2007 and they come into force on 30 November 2007.

(2) These Regulations apply in relation to Wales.

(1) 1970 c.40. Section 66(1) contains the definitions of the expressions "the Ministers", "prescribed" and "regulations". The functions of the Ministers and the Secretary of State so far as exercisable in relation to Wales, were transferred to the National Assembly for Wales by S.I.1999/672 and were transferred to the Welsh Ministers by virtue of 162 of and paragraph 30 of Schedule 11 to the Government of Wales Act 2006 (c.32). Section 74A was inserted by the European Communities Act 1972 (c.68), Schedule 4, paragraph 6.

**Diwygiadau i Reoliadau Bwydydd Anifeiliaid
(Cymru) 2006**

2.-(1) Diwygir Rheoliadau Bwydydd Anifeiliaid (Cymru) 2006(1) yn unol â pharagraffau (2) i (5).

(2) Ym mharagraff 11(2)(c)(iv) o Ran 1 o Atodlen 3 (cynnwys yr offeryn statudol neu ddatganiad arall etc), yn lle'r gair "soluble" rhodder "insoluble".

(3) Mae'r cofnodion tabl a'r troednodiadau sy'n ffurfio Pennod D o Atodlen 5 (terfynau rhagnodedig ar gyfer sylweddau annymunol) wedi'u disodli gan y cofnodion a'r troednodiadau a nodir yn Atodlen 1 i'r Rheoliadau hyn.

(4) Mae'r cofnodion tabl a nodir yn Atodlen 2 i'r Rheoliadau hyn wedi'u hychwanegu ar ddiwedd y tabl yn Atodlen 6 (rheoli ffynonellau protein penodol).

(5) Yng ngholofn 4 o Bennod A o Atodlen 7 (bwydydd anifeiliaid a ganiateir ac a fwriedir at ddibenion maethol neilltuol a darpariaethau ynghylch eu defnyddio), gyferbyn â'r cofnod yng ngholofn 1 ynghylch lleihau cyfraddau ffurfiant cerrig cystin, yn lle'r gair "acidifying" rhodder "alkalising".

**Amendments to the Feeding Stuffs (Wales)
Regulations 2006**

2.-(1) The Feeding Stuffs (Wales) Regulations(1) are amended in accordance with paragraphs (2) to (5).

(2) In paragraph 11(2)(c)(iv) of Part 1 of Schedule 3 (contents of the statutory statement or other declaration etc), for the word "soluble" substitute "insoluble".

(3) The table entries and footnotes comprising Chapter D of Schedule 5 (prescribed limits for undesirable substances) are replaced by the entries and footnotes set out in Schedule 1 to these Regulations.

(4) The table entries set out in Schedule 2 to these Regulations are added at the end of the table in Schedule 6 (control of certain protein sources).

(5) In column 4 of Chapter A of Schedule 7 (permitted feeding stuffs intended for particular nutritional purposes and provisions relating to their use), opposite the entry in column 1 relating to reduction in cystine stones formation, for the word "acidifying" substitute "alkalising".
