**EXPLANATORY NOTE**

Mae'r Ddeddf Gwahaniaethu ar sail Anabledd 2005 ("y Ddeddf") yn diwygio'n helaeth Ddeddf Gwahaniaethu ar sail Anabledd 1995 ("Deddf 1995"), a gwneud darpariaethau penodol eraill.

The Disability Discrimination Act 2005 ("the Act") extensively amends the Disability Discrimination Act 1995 ("the 1995 Act"), and makes certain other provisions.

Mae erthygl 2 yn dwyn i rym "ddarpariaethau bathodyn glas" y Ddeddf, y mae ei rhychwant yn gyfyngedig i Gymru a Lloegr (adran 20(8)), o ran Cymru yn unig. Dyma yw darpariaethau'r bathodyn glas: adran 9, Rhan 2 o Atodlen 1, cofnodion penodol yn Atodlen 2 ac adran 19 i'r graddau y mae'n ymwneud â'r darpariaethau hynny yn yr Atodlenni hynny (adran 20(10)).

Article 2 brings into force the "blue badge provisions" of the Act, the extent of which is limited to England and Wales (section 20(8)), in relation to Wales only. The blue badge provisions are: section 9, Part 2 of Schedule 1, certain entries in Schedule 2 and section 19 so far as it relates to those provisions in those Schedules (section 20(10)).

**Title, application and interpretation**

1.-(1) Enw'r Gorchymyn hwn yw Gorchymyn Deddf Gwahaniaethu ar sail Anabledd 2005 (Cychwyn Rhif 1) (Cymru) 2007 ac mae'n gymwys o ran Cymru.

1.-(1) The title of this Order is the Disability Discrimination Act 2005 (Commencement No.1) (Wales) Order 2007 and it applies in relation to Wales.

ystyr "y Ddeddf" ("*the Act*") yw Deddf Gwahaniaethu ar sail Anabledd 2005;

"the Act" means the Disability Discrimination Act 2005;

ystyr "Deddf 1995" ("*the 1995 Act*") yw Deddf Gwahaniaethu ar sail Anabledd 1995;(3).

"the 1995 Act" means the Disability Discrimination Act 1995(3).
