Mae'r Rheoliadau hyn yn dirymu Rheoliadau Addysg (Gwybodaeth am Ddisgyblion Unigol) (Cymru) 2003 a Rheoliadau Addysg (Gwybodaeth am Ddisgyblion Unigol) (Personau Rhagnodedig) (Cymru) 2004 ac yn eu hailanddod fel y'u diwygiwyd. Mae'r Rheoliadau hyn yn ei gwneud yn ofynnol i gorff llywodraethu unrhyw ysgol a gynhelir, pan fydd cais ysgrifenedig yn dod i law oddi wrth yr awdurdod addysg lleol sy'n cynnal yr ysgol, gyflenwi, o fewn pedair diwrnod ar ddeg, y cyfryw wybodaeth y cyfeirir ati yn yr Atodlen ag y bydd yr awdurdod yn gofyn amdano mewn cysylltiad â disgyblion yn yr ysgol.

Mae rheoliad 5 yn rhagnodi'r personau y caniateir i Weinidogion Cymru roi gwybodaeth iddynt am ddisgyblion unigol o dan adran 537A(4) o Ddeddf Addysg 1996, a'r wybodaeth am ddisgyblion unigol y caniateir i "gydlynwyr gwybodaeth" ei darparu. O gymhwys o Gymru y diffiniad o gydlynnydd gwybodaeth a geir yn adran 537A(9) o Ddeddf Addysg 1996, cydlynnydd gwybodaeth yw unrhyw gorff sydd yn gyfrifol, at ddibenion swyddogaethau addysg Gweinidogion Cymru neu mewn cysylltiad â'r swyddogaethau hynny, am gydlynwyr neu wirio gwybodaeth sy'n ymwneud â disgyblion. Mae'r wybodaeth y mae'r Rheoliadau hyn yn caniatáu iddynt ei darparu yn ymwneud â chyflawniadau addysgol disgyblion mewn unrhyw arholiadau TAG Safon Uwch, unrhyw arholiadau TAG Uwch Gyfrannol, unrhyw bynciau GNVQ ac mewn unrhyw gwrs astudiaeth a ddarperir ar gyfer disgyblion o oedran ysgol gorfodol mewn ysgol a gynhelir gan awdurdod addysg lleol ac sy'n gwrs sy'n arwain at gymhwyster a gymeradwyir gan Weinidogion Cymru neu gan gorff a ddynodir gan Weinidogion Cymru o dan adran 99 o Ddeddf Dysgu a Medrau 2000.

The Education (Information About Individual Pupils) (Wales) Regulations 2007

**EXPLANATORY NOTE**

*(This note is not part of the Regulations)*

These Regulations revoke the Education (Information About Individual Pupils) (Wales) Regulations 2003 and the Education (Individual Pupil Information) (Prescribed Persons) (Wales) Regulations 2004 and substantially re-enact them as amended. These Regulations require the governing body of any maintained school on receiving a written request from the local education authority by which the school is maintained to supply within fourteen days such of the information referred to in the Schedule as may be requested by the authority in respect of pupils at the school.

Regulation 5 prescribes which persons may be provided with individual pupil information by the Welsh Ministers under section 537A(4) of the Education Act 1996 and which individual pupil information may be provided by "information collators". Applying the definition of an information collator in section 537A(9) of the Education Act 1996 to Wales, an information collator is any body which, for the purposes of or in connection with the education functions of the Welsh Ministers, is responsible for collating or checking information relating to pupils. The information which they may provide by these Regulations relates to the educational achievements of pupils in any GCE "A" level examinations, any GCE "AS" examinations, any GNVQ subjects and any course of study provided to pupils of compulsory school age in a school maintained by a local education authority leading to a qualification which is approved by the Welsh Ministers or by a body designated by the Welsh Ministers under section 99 of the Learning and Skills Act 2000.

The Education (Information About Individual Pupils) (Wales) Regulations 2007

Made 17 December 2007

Laid before the National Assembly for Wales 20 December 2007

Coming into force 14 January 2008

The Welsh Ministers in exercise of the powers conferred on the Secretary of State by sections 537A(1), (2) and (4) and 569(4) and (5) of the Education Act 1996(1) and now vested in them(2) make the following Regulations.

**Title, commencement and application**

1.—(1) The title of these Regulations is the Education (Information About Individual Pupils) (Wales) Regulations 2007 and come into force on 14 January 2008.

(2) These Regulations apply in relation to Wales.

**Revocation**

2. The regulations in Schedule 1 are revoked.

**Interpretation**

3. In these Regulations—

"the 1996 Act" ("Deddf 1996") means the Education Act 1996;

"individual pupil information" ("gwybodaeth am ddisgyblion unigol") means information within the meaning of section 537A(9) of the 1996 Act, namely information relating to and identifying individual pupils or former pupils (at schools in Wales), whether obtained under section 537A(1) of the 1996 Act or otherwise;

"information collator" ("cydlynydd gwybodaeth") means an information collator within section 537A(9) of the 1996 Act, namely any body which, for the purposes of or in connection with the functions of the Welsh Ministers relating to education, is responsible for collating or checking information relating to pupils;

"key stage" ("cyfnod allweddol") means any of the periods set out in paragraphs (a) to (d) respectively of section 103(1) of the 2002 Act and a reference to the first, second or third key stage is a reference to the periods set out respectively in paragraphs (a), (b) and (c) of the said section 103(1);

"learning activity reference" ("cyfeirnod gweithgaredd dysgu") means a combination of numbers which together with a letter are allocated to a course of study or other learning activity and are particular to that course or learning activity, and are determined by the Welsh Ministers;

ystyr "rhif unigryw disgybl" ("unique pupil number") yw cyfuniad o rifau sydd, ynghyd â llythyren neu lythrennau, yn cael eu dyrannu i ddisgybl ac sy'n benodol i'r disgybl hwnnw, drwy ddefnyddio fformiwl a benderfynwyd gan Weinidogion Cymru;

"permanent exclusion date" ("dyddiad gwahardd parhaol") means the date on which the name of a permanently excluded pupil is deleted from the register;

"register" ("cofrestr") means the register of pupils kept under section 434(2) of the 1996 Act and in accordance with the Education (Pupil Registration) Regulations 1995(3);

"school" ("ysgol") means a school maintained by a local education authority, but does not include a pupil referral unit;

"school sessions" ("sesiynau ysgol") is to be interpreted in accordance with regulation 4 of the Education (School Day and School Year) (Wales) Regulations 2003(4);

"school year" ("blwyddyn ysgol") means the period beginning with the first school term to begin after July and ending with the beginning of the first such term to begin after the following July;

"sixth form pupil" ("disgybl chweched dosbarth") means a pupil at a school, which is not a special school, who is in receipt of education suitable to the requirements of pupils above compulsory school age;

"special school" ("ysgol arbennig") has the meaning given by section 337 of the 1996 Act(5);

"special educational needs" ("anghenion addysgol arbennig") has the meaning given to it by section 312 of the 1996 Act;

"unauthorised absence" ("absenoldeb nas awdurdodwyd") means an occasion on which a pupil is recorded as absent without authority pursuant to the Education (Pupil Registration) Regulations 1995 and "authorised absence" ("absenoldeb a awdurdodwyd") is to be construed accordingly; and

O fewn pedwar diwrnod ar ddeg ar ôl cael cais ysgrifenedig gan yr awdurdod addysg lleol y cynhelir ysgol ganddo, rhaid i'r corff llywodraethu roi i'r awdurdod ar ffurf sy'n ddarllenadwy gan beiriant, drwy wefan ddiogel ar y rhyngrywd a ddarparwyd at y diben hwnnw gan Weinidogion Cymru, gymaint o'r wybodaeth y cyfeirir ati yn Atodlen 2 i'r Rheoliadau hyn ag y gofynnir amdani felly.

### **Personau Rhagnodedig**

5.—(1) At ddibenion adran 537A(4) o Ddeddf 1996, mae Gweinidogion Cymru yn rhagnodi'r canlynol yn berson y caniateir iddynt ddarparu ar ei gyfer wybodaeth am ddisgyblion unigol—

- (a) unrhyw berson y cyfeirir ato ym mharagraff (2) isod; a
- (b) unrhyw berson sy'n perthyn i'r categori y cyfeirir ato ym mharagraff (3) isod.

(2) Y personau y cyfeirir atynt ym mharagraff (1)(a) uchod yw—

- (a) yr awdurdod addysg lleol sy'n cynnal yr ysgol y cofrestrir neu y cofrestrwyd y disgylbwyr sy'n destun yr wybodaeth honno ynddi, neu, yn achos ysgol nas cynhelir felly, awdurdod addysg lleol yr ardal y lleolir ynddi'r ysgol y cofrestrir neu y cofrestrwyd y disgylbwyr sy'n destun yr wybodaeth honno ynddi;
- (b) person sy'n dal Swydd Prif Arolygydd Ei Mawrhydi dros Addysg a Hyfforddiant yng Nghymru neu Her Majesty's Chief Inspector of Education and Training in Wales;
- (c) Uned Ddata Llywodraeth Leol Cymru; ac

"unique pupil number" ("rhif unigryw disgylbwyr") means a combination of numbers which together with a letter or letters are allocated to a pupil and are particular to that pupil, by use of a formula determined by the Welsh Ministers.

### **Provision of information by schools maintained by local education authorities to their local education authorities**

4. Within fourteen days of receiving a request in writing from the local education authority by which a school is maintained, the governing body must provide to the authority in machine readable format, through a secure internet website provided for that purpose by the Welsh Ministers, such of the information referred to in Schedule 2 to these Regulations as is so requested.

### **Prescribed Persons**

5.—(1) For the purposes of section 537A(4) of the 1996 Act, the Welsh Ministers prescribe as a person to whom they may provide individual pupil information—

- (a) any person referred to in paragraph (2) below; and
- (b) any person falling within the category referred to in paragraph (3) below.

(2) The persons referred to in paragraph (1)(a) above are—

- (a) the local education authority which maintains the school at which the pupil who is the subject of that information is or was registered or, in the case of a school which is not so maintained, the local education authority for the area in which the school is situated, at which the pupil who is the subject of that information is or was registered;
- (b) a person holding the Office of Her Majesty's Chief Inspector of Education and Training in Wales or Prif Arolygydd Ei Mawrhydi dros Addysg a Hyfforddiant yng Nghymru;
- (c) Local Government Data Unit-Wales; and

- (b) unrhyw berson sy'n perthyn i'r categori y cyfeirir ato ym mharagraff (7) isod.

(5) Yr wybodaeth am ddisgyblion unigol y caniateir i gydlynnydd gwybodaeth ei rhoi felly, ar yr adegau y byddo i Weinidogion Cymru benderfynu arnynt, yn unol ag adran 537A(5)(b) o Ddeddf 1996, yw unrhyw wybodaeth o'r fath sy'n ymwneud â chyflawniadau addysgol disgylion yn y canlynol—

- (a) unrhyw asesiad Cwricwlwm Cenedlaethol a wneir o ddisgyblion yng nghyfnod allweddol un, dau neu dri;
- (b) unrhyw bynciau TGAU;
- (c) unrhyw arholiadau TAG Safon Uwch;
- (ch) unrhyw arholiadau TAG Uwch Gyfrannol;
- (d) unrhyw bynciau GNVQ; ac
- (dd) unrhyw gwrs astudio a ddarperir ar gyfer disgylion o oedran ysgol gorfodol yn unrhyw ysgol a gynhelir gan awdurdod addysg lleol sy'n gwrs sy'n arwain at gymhwyster a gymeradwyir gan Weinidogion Cymru neu gan gorff a ddynodwyd gan Weinidogion Cymru o dan adran 99 o Ddeddf Dysgu a Medrau 2000(2) (ac eithrio cymhwyster o'r math y cyfeirir ato yn is-baragraff (b) neu (d) uchod).

(6) Y personau y cyfeirir atynt ym mharagraff (4)(a) uchod yw—

(d) the Careers Wales companies established to provide careers services in Wales under sections 2, 8, and 10 of the Employment and Training Act 1973(1).

(3) The category referred to in paragraph (1)(b) above is that of persons conducting research into the educational achievements of pupils and who require individual pupil information for that purpose.

(4) For the purposes of section 537A(5)(b) of the 1996 Act, the Welsh Ministers prescribe as a person to whom an information collator may provide individual pupil information—

- (a) any person referred to in paragraph (6) below; and
- (b) any person falling within the category referred to in paragraph (7) below.

(5) The individual pupil information which an information collator may so provide, at such times as the Welsh Ministers may determine, in accordance with section 537A(5)(b) of the 1996 Act, is any such information relating to the educational achievements of pupils in—

- (a) any National Curriculum assessment of pupils in the first, second or third key stage;
- (b) any GCSE subjects;
- (c) any GCE "A" level examinations;
- (d) any GCE "AS" examinations;
- (e) any GNVQ subjects; and
- (f) any course of study provided to pupils of compulsory school age in any school maintained by a local education authority which leads to a qualification which is approved by the Welsh Ministers or a body designated by the Welsh Ministers under section 99 of the Learning and Skills Act 2000(2) (other than a qualification of the kind referred to in sub-paragraph (b) or (e) above).
