Mae'r Gorchymyn hwn yn dod â darpariaethau Deddf Llywodraeth Leol a Chynnwys y Cyhoedd mewn Iechyd 2007 ("Deddf 2007") i rym o ran Cymru ac eithrio i'r graddau y maent yn ymwneud ag awdurdod heddlu ar gyfer ardal heddlu yng Nghymru.

This Order brings into force provisions of the Local Government and Public Involvement in Health Act 2007 ("the 2007 Act") in relation to Wales except so far as they relate to a police authority for a police area in Wales.

Mae erthygl 2 o'r Gorchymyn hwn yn dod â'r darpariaethau a ganlyn o Ddeddf 2007 i rym ar 1 Ebrill 2008:

Article 2 of this Order brings into force on 1 April 2008 the following provisions of the 2007 Act:

- (a) adran 137, sy'n mewnosod adran 3(4) newydd yn Neddf Llywodraeth Leol 1999 ("Deddf 1999") fel bod rhaid i awdurdod, wrth benderfynu ar sut i gyflawni ei ddyletswydd o dan adran 3(1) o Ddeddf 1999 ac wrth benderfynu â phwy i ymgynghori o dan adran 3(2) o'r Ddeddf honno ac ar ffurf, cynnwys ac amseriad y cyfryw ymgynghoriadau, roi sylw i unrhyw ganllawiau a ddyroddir gan Weinidogion Cymru;
- (b) adran 140, sy'n hepgor adran 5 o Ddeddf 1999 (dyletswydd ar awdurdod i gynnal adolygiadau gwerth gorau);
- (c) adran 210, sy'n galluogi Gweinidogion Cymru, i wneud darpariaeth o ran Cymru, drwy orchymyn, yn cymhwyso unrhyw ddarpariaethau o adrannau 205 i 208 o Ddeddf 2007 sy'n ymwneud â chydawdurdodau gwastraff; ac

- (a) section 137, which substitutes a new section 3(4) into the Local Government Act 1999 ("the 1999 Act") such that, in deciding how to fulfil its duty under section 3(1) of the 1999 Act and in deciding who to consult under section 3(2) of that Act and the form, content and timing of such consultations, an authority must have regard to any guidance issued by the Welsh Ministers;
- (b) section 140, which omits section 5 of the 1999 Act (duty upon an authority to conduct best value reviews);
- (c) section 210, which enables the Welsh Ministers to, by order, make provision in relation to Wales applying any provisions of sections 205 to 208 of the 2007 Act which concern joint waste authorities; and

(ch) adran 241, i'r graddau y mae'n ymwneud â'r diddymiadau yn Rhan 8 o Atodlen 18 o ddarpariaethau yn Neddf 1999 a Deddf Llywodraeth Leol 2000 ynghylch adran 5 o Ddeddf 1999.

(d) section 241, in so far as it relates to the repeals in Part 8 of Schedule 18 of provisions in the 1999 Act and the Local Government Act 2000 concerning section 5 of the 1999 Act.

1.—(1) The title of this Order is the Local Government and Public Involvement in Health Act 2007 (Commencement) (Wales) Order 2008.

(2) This Order applies in relation to Wales save in relation to a police authority for a police area in Wales.
