**1.** Mae'r Rheoliadau hyn yn gwneud diwygiadau pellach i Reoliadau Bwydydd Anifeiliaid (Cymru) 2006 (O.S. 2006/116 (Cy.14) a ddiwygiwyd eisoes gan O.S. 2006/617 (Cy.69), O.S. 2006/2928 (Cy. 263), O.S. 2006/3256 (Cy.296), O.S. 2007/3171 (Cy.277) ac O.S. 2008/1806 (Cy.174)) ("y Rheoliadau Bwydydd Anifeiliaid").

**2.** Mae'r Rheoliadau hyn yn darparu ar gyfer gweithredu—

- (a) Cyfarwyddeb y Comisiwn 2008/76/EC sy'n diwygio Atodiad I i Gyfarwyddeb 2002/32/EC Senedd Ewrop a'r Cyngor ar sylweddau annymunol mewn bwyd anifeiliaid ( OJ Rhif L198, 26.7.2008, t.37); a
- (b) Cyfarwyddeb y Comisiwn 2008/82/EC sy'n diwygio Cyfarwyddeb 2008/38/EC o ran bwydydd anifeiliaid a fwriedir ar gyfer cefnogi swyddogaeth arenol mewn achos o annigonolrwydd cronic yr arenau (OJ Rhif L202, 31.7.2008, t.48).

**3.** O ran paragraff 2(a), mae'r Rheoliadau hyn yn diwygio Atodlen 5 (cyfyngiadau rhagnodedig ar gyfer sylweddau annymunol) i'r Rheoliadau Bwydydd Anifeiliaid. Mae'r newidiadau'n ymwned â fflworin, cynhyrchion planhigion penodol a DDT.

**4.** O ran paragraff 2(b), mae'r Rheoliadau hyn yn diwygio'r tabl yn Atodlen 7 (bwydydd anifeiliaid a ganiateir at ddibenion maethiadol penodol a darpariaethau yngylch eu defnyddio) i'r Rheoliadau Bwydydd Anifeiliaid, drwy ddisodli'r cofnodion presennol yngylch cefnogi swyddogaeth arenol mewn achos o annigonolrwydd cronic yr arenau.

**The Feeding Stuffs (Wales)  
(Amendment) Regulations 2009**

**EXPLANATORY NOTE**

*(This note is not part of the Regulations)*

**1.** These Regulations further amend the Feeding Stuffs (Wales) Regulations 2006 (S.I. 2006/116 (W.14) as already amended by S.I. 2006/617 (W.69), S.I. 2006/2928 (W. 263), S.I. 2006/3256 (W.296), S.I. 2007/3171 (W.277) and S.I. 2008/1806 (W.174)) ("the Feeding Stuffs Regulations").

**2.** These Regulations provide for the implementation of—

- (a) Commission Directive 2008/76/EC amending Annex I to Directive 2002/32/EC of the European Parliament and of the Council on undesirable substances in animal feed (OJ No. L198, 26.7.2008, p.37); and
- (b) Commission Directive 2008/82/EC amending Directive 2008/38/EC as regards feeding stuffs intended for the support of the renal function in case of chronic renal insufficiency (OJ No. L202, 31.7.2008, p.48).

**3.** In respect of paragraph 2(a), these Regulations amend Schedule 5 (prescribed limits for undesirable substances) to the Feeding Stuffs Regulations. The changes relate to fluorine, certain plant products and DDT.

**4.** In respect of paragraph 2(b), these Regulations amend the table in Schedule 7 (permitted feeding stuffs intended for particular nutritional purposes and provisions relating to their use) to the Feeding Stuffs Regulations, by replacing the existing entries relating to the support of renal function in cases of chronic renal insufficiency.

The Welsh Ministers make the following Regulations in exercise of the powers conferred by sections 66(1), 68(1), 69(1), 74A and 84 of the Agriculture Act 1970(1).

There has been consultation during the preparation of these Regulations in accordance with the requirements of section 84(1) of the Agriculture Act 1970 or, as appropriate, of Article 9 of Regulation (EC) No. 178/2002 of the European Parliament and of the Council(2) laying down the general principles and requirements of food law, establishing the European Food Safety Authority and laying down procedures in matters of food safety.

**Title, commencement and application**

1.—(1) The title of these Regulations is The Feeding Stuffs (Wales) (Amendment) Regulations 2009 and they come into force on 20 February 2009.

(2) These Regulations apply in relation to Wales.

Functions of "the Ministers", so far as exercisable in relation to Wales, were transferred to the National Assembly for Wales by S.I. 1999/672 and thereafter transferred to the Welsh Ministers by paragraph 30 of Schedule 11 to the Government of Wales Act 2006 (c.32). Section 74A was inserted by the European Communities Act 1972 (c. 68), Schedule 4, paragraph 6.

## Amendment of the Feeding Stuffs (Wales) Regulations 2006

2.—(1) The Feeding Stuffs (Wales) Regulations 2006(1) are amended in accordance with paragraphs (2) and (3).

(2) In Schedule 5 (prescribed limits for undesirable substances)—

- (a) in Chapter A, in the entries relating to fluorine—
  - (i) after the last entry in Column 2 add "— complete feeding stuffs for fish", and
  - (ii) after the last entry in Column 3 add "350";
- (b) in Chapter C—
  - (i) omit the entries relating to *Apricots, Bitter almond and Camelina*;
  - (ii) for the entries relating to *Weed seeds etc.* substitute the following —
