Mae'r Rheoliadau hyn yn diwygio Rheoliadau Iechyd Planhigion (Ffioedd Arolygu Mewnforio) (Cymru) (Rhif 2) 2006 (O.S. 2006/2832) ("y prif Reoliadau"). Mae'r prif Reoliadau'n gweithredu Erthygl 13d o Gyfarwyddeb y Cyngor 2000/29/EC (OJ Rhif L169, 10.7.00, t.1), sy'n ei gwneud yn ofynnol i Aelod-wladwriaethau godi ffioedd i dalu'r costau a geir oherwydd gwiriadau dogfenol, gwiriadau adnabod a gwiriadau iechyd planhigion ar fewnforion penodol o ran planhigion, cynhyrchion planhigion a phethau eraill o drydydd gwledydd.

These Regulations amend the Plant Health (Import Inspection Fees) (Wales) (No. 2) Regulations 2006 (S.I. 2006/2832) ("the principal Regulations"). The principal Regulations implement Article 13d of Council Directive 2000/29/EC (OJ No. L169, 10.7.00, p.1), which requires member States to charge fees to cover the costs occasioned by the documentary checks, identity checks and plant health checks of certain imports of plants, plant products and other objects from third countries.

Mae'r Rheoliadau hyn yn gosod Atodlen 2 newydd i'r prif Reoliadau yn lle'r un bresennol, i roi eu heffaith i'r cyfraddau gostyngol diweddaraf y cytunwyd arnynt ar gyfer arolygiadau o ddeunydd penodol. (Mae Atodlen 2 i'r prif Reoliadau yn cynnwys darpariaeth am gyfraddau gostyngol ar gyfer planhigion penodol a chynhyrchion planhigion penodol a'r rheini'n gyfraddau y cytunwyd arnynt o dan y weithdrefn y darperir ar ei chyfer yn Erthyglau 13d(2) a 18(2) o'r Gyfarwyddeb.) Mae'r newidiadau i'r ffioedd a wneir gan y Rheoliadau hyn, sydd wedi'u gosod ar gyfran o'r ffi safonol (a ddisgrifir yn Atodlen 1 i'r prif Reoliadau) sy'n cyfateb i'r gyfradd arolygu, yn seiliedig ar y cyfraddau arolygu y cytunwyd arnynt ac a nodir isod:

These Regulations substitute a new Schedule 2 to the principal Regulations, to give effect to the latest agreed reduced rates for inspections of certain material. (Schedule 2 to the principal Regulations includes provision for reduced rates for certain plants and plant products agreed under the procedure provided for in Articles 13d(2) and 18(2) of the Directive.) The changes to the fees made by these Regulations, which are set at a proportion of the standard fee (described in Schedule 1 to the principal Regulations) corresponding to the rate of inspection, are based on the agreed inspection rates set out below:

The Welsh Ministers, with the consent of the Treasury, make the following Regulations in exercise of the powers conferred by section 56(1) of the Finance Act 1973(1).

Title, application and commencement

1. The title of these Regulations is the Plant Health (Import Inspection Fees) (Wales) (Amendment) Regulations 2009, they apply in relation to Wales and come into force on 23 March 2009.

Amendment to the Plant Health (Import Inspection Fees) (Wales) (No. 2) Regulations 2006

2.—(1) The Plant Health (Import Inspection Fees) (Wales) (No. 2) Regulations 2006(2) are amended in accordance with this regulation.

(2) In regulation 4(1)(a)(ii) omit "the fee specified".
