The Welsh Ministers in exercise of the powers conferred upon them by sections 40 and 44(3) and (5) of the Children and Young Persons Act 2008(1), make the following Order:

Title, Interpretation and Application

1.—(1) The title of this Order is the Children and Young Persons Act 2008 (Commencement No. 1) (Wales) Order 2009.

(2) In this Order "the Act" ("*Y Ddeddf*") means the Children and Young Persons Act 2008.

(3) This Order applies in relation to Wales.

Appointed Day

2. 6 April 2009 is the appointed day for the coming into force of the following provisions of the Act —

- (a) section 30 (removal of restriction on hearing of application for discharge of emergency protection order);
- (b) section 35 (extension of period allowed for making regulations under section 45 or 46 of the Children Act 2004(2)); and
- (c) section 42 and Schedule 4 (repeals) in so far as they relate to the repeal of section 45(9) of the Children Act 1989(3).
