Mae'r Gorchymyn hwn yn dwyn i rym ar 31 Hydref 2010 adrannau 45 a 46 o Ddeddf Lleihau Troseddu Treisgar 2006 o ran Cymru.

This Order brings into force on 31 October 2010 sections 45 and 46 of the Violent Crime Reduction Act 2006 in relation to Wales.

Mae adran 45 o'r Ddeddf honno'n mewnosod, yn Neddf Addysg 1996, adran newydd 550AA sy'n ymwneud â phŵer aelodau o staff i chwilio disgyblion am arfau.

Section 45 of that Act inserts a new section 550AA into the Education Act 1996 relating to the power of members of staff to search pupils for weapons.

Mae adran 46 o'r Ddeddf honno'n mewnosod, yn Neddf Addysg Bellach ac Uwch 1992, adran newydd 85B sy'n ymwneud â'r pŵer i chwilio disgyblion addysg bellach am arfau.

Section 46 of that Act inserts a new section 85B into the Further and Higher Education Act 1992 relating to the power to search further education students for weapons.
