The A470 Trunk Road (Maenan, North of Llanrwst, Conwy) (Temporary Traffic Restrictions and Prohibition) Order 2011

Made 7 *June 2011*

Coming into force

20 June 2011

The Welsh Ministers, being the traffic authority for the relevant length of the Maentwrog – East of Conwy Trunk Road (A470) (hereinafter referred to as "the trunk road"), are satisfied that traffic in a specified length of the trunk road should be restricted and prohibited by reason of works proposed to be executed thereon.

The Welsh Ministers, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

1. This Order comes into force on 20 June 2011. The title to this Order is The A470 Trunk Road (Maenan, North of Llanrwst, Conwy) (Temporary Traffic Restrictions and Prohibition) Order 2011.

2.—1) In this Order:

"the length of the trunk road" ("y darn o'r gefnffordd") means that length of the A470 Maentwrog – East of Conwy Trunk Road, Maenan, north of Llanrwst in the County Borough of Conwy, which extends from a point at its junction with the Class 3 road adjacent to the property known as Troed y Rhiw to a point at its junction with the access to Bod Hyfryd Farm;

"works period" ("cyfnod y gwaith") means that period commencing at 00.01 hours on 20 June 2011 and ending when the temporary traffic signs are permanently removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

- **3.** Subject to the provisions of article 6, no person shall, during the works period, ride, drive or cause or permit any vehicle to proceed at a speed exceeding 40 miles per hour, in the length of the trunk road.
- **4.** Subject to the provisions of article 6, no person shall, during the works period, ride, drive or cause or permit any vehicle to proceed at a speed exceeding 10 miles per hour, in the length of the trunk road.
- **5.** Subject to the provisions of article 6, no person shall, during the works period, use or permit the use of a vehicle in such a way that it overtakes any other vehicle in the length of the trunk road.
- **6.** The provisions of articles 3, 4 and 5, shall apply only during such times and to such extent as the application of the restrictions and prohibition referred to therein is indicated by traffic signs.
- **7.** The maximum duration for this Order shall be 6 months
