**EXPLANATORY NOTE**

*(This note is not part of the Order)*

This Order designates the area described in the Schedule as a civil enforcement area and a special enforcement area for the purposes of Part 6 of the Traffic Management Act 2004. The practical effect of the Order is to enable Powys County Council to enforce parking contraventions within the area described in the Schedule to the Order through a civil law regime, as opposed to enforcement by police or traffic wardens in a criminal law context.

This Order is made in exercise of the powers conferred on the National Assembly for Wales by paragraph 8(1) of Schedule 8 and paragraph 3(1) of Schedule 10 to the Traffic Management Act 2004(1) and now vested in the Welsh Ministers(2).

Powys County Council has applied to the Welsh Ministers for an order to be made under these powers with respect to part of its area.

The Welsh Ministers have consulted the chief officer of Dyfed Powys Police in accordance with the requirements of paragraphs 8(3) of Schedule 8 and 3(4) of Schedule 10 to the Traffic Management Act 2004.

Accordingly, the Welsh Ministers make this Order.

**Title and commencement**

1. This Order is called the Civil Enforcement of Parking Contraventions (County of Powys) Designation Order 2011 and comes into force on 1 April 2011.

#### Ardal a ddynodir yn ardal gorfodi sifil ar dramgwyddau parcio ac yn ardal gorfodi arbennig

Mae'r Gorchymyn hwn yn gymwys i'r cyfan o Sir Powys ac eithrio'r darn o ffordd sydd wedi ei adeiladu o fewn Ardal Hyfforddi Pontsenni, Pontsenni yn Sir Powys sy'n rhedeg o gyffordd ffyrdd C45 ac L167 wrth bwynt tua 0.6 cilometr i'r dwyrain o Dirabad ac yn croesi Mynydd Bwlch-y-Groes mewn cyfeiriad de-orllewinol cyffredinol hyd at ei chyffordd â'r ffordd ddosbarth C49 wrth Church Hill wrth bwynt tua 1.85 cilometr i'r gogledd-orllewin o Lywel, pellter o tua 11.7 o kilometrau i gyd.

## SCHEDULE

### Article 2

#### Area designated as a civil enforcement area for parking contraventions and a special enforcement area

This Order applies to the whole of the County of Powys with the exception of the length of road constructed within the Sennybridge Training Area, Sennybridge in the County of Powys which runs from the junction of the roads C45 and L167 at a point approximately 0.6 kilometres east of Tirabad and crosses Mynydd Bwlch-y-Groes in a general south westerly direction to its junction with the classified road C49 at Church Hill at a point approximately 1.85 kilometres north west of Llywel, a distance of approximately 11.7 kilometres in total.
